Lok Sabha election 2019: Polling in West Bengal in 7 phases

The Election Commission on Sunday announced that the Lok Sabha election in West Bengal will be held over seven phases, beginning from April 11 and continue till May 19. The counting of votes for all the seats will take place on May 23. In Phase 1, polling will take place in West Bengal for two constituencies (Cooch Behar and Alipurduar), in Phase 2 polling will take place for three constituencies (Jalpaiguri, Darjeeling, and Raiganj), in Phase 3 polling will be done in five constituencies (Balurghat, Malda uttar, Malda dakshin, Jangipur, Murshidabad).

NK Singh appointed chairman of 15th Finance Commission

The government on Monday announced that former revenue secretary NK Singh will be the chairman of the 15th Finance Commission (FC) that will recommend distribution of taxes between the Centre and the states. Other members of the Commission are former economic affairs secretary Shaktikanta Das, former chief economic adviser Ashok Lahiri, Niti Aayog member Ramesh Chand and Georgetown University Adjunct Professor Anoop Singh. The Commission will work on "the principles which should govern the grants-in-aid of the revenues of the States out of the Consolidated Fund of India and the sums to be paid to the States by way of grants-in-aid of their revenues under Article 275 of the Constitution.

Jet Airways' Chairman Naresh Goyal resigns

Jet Airways promoter and founder Naresh Goyal on Monday resigned from the company's board. The resignation followed the airline board's meeting in Mumbai on the day to decide on ways to procure interim funding as well as the future role of Goyal. Sources said Goyal tendered his resignation at the emergency board meeting. "The main agenda, however, is to get interim funding," said a source. It was expected that after the meeting the State Bank of India.

The BJP has fielded Prime Minister Narendra Modi from Varanasi constituency and its president Amit Shah from Gandhinagar in place of L.K. Advani in its first list of 184 candidates. Senior party leader J.P. Nadda has told a press conference that the party also decided to field Home Minister Rajnath Singh from Lucknow and another Union Minister Nitin Gadkari from Nagpur. Union Minister Smriti Irani has been renominated from Amethi and will take on Congress president Rahul Gandhi.

Tata Starbucks appoints new CEO

MUMBAI: Tata Starbucks has announced Navin Gurnaney as its chief executive officer effective January 1, 2019. He will replace Sumitro Ghosh who will returns to the US parent company after a three-year stint. The company said Gurnaney will be responsible for driving Tata Starbucks overall strategic direction and vision in India and further strengthening Starbucks business growth. With this role, he is returning to Starbucks after first joining in 2004 where he was a leader on US business.

L&T makes Rs 10,800 crore takeover bid for Mindtree

In the country's first hostile takeover bid in the IT sector, infrastructure giant Larsen & Toubro Monday made an offer to buy up to 66 per cent stake in the Mindtree for around Rs 10,800 crore. L&T has entered into a deal to buy Cafe Coffee Day owner V G Siddhartha's 20.32 per cent stake in Mindtree and has also placed an order with brokers to pick up another 15 per cent of the company shares from the open market.

Indian General Election dates 2019 schedule is out and the national election will be held in seven rounds from April 11 and the results will be announced on May 23. This general election will choose the 17th Lok Sabha. The members of the largest party or coalition will then choose the Prime Minister.

NEW DELHI: Prime Minister Narendra Modi announced Wednesday the successful test of India anti-satellite (ASAT) missile system test. The classified test successfully destroyed a low earth orbit (LEO) satellite. With this test, India has become the 4th nation after US, China, and Russia to have this particular anti-satellite capability. In 2010, the then DRDO chief and Scientific Advisor to the defence minister, V.K. Saraswat, had asserted that India did have anti-satellite capability.

What does east-west classification of Uttar Pradesh by Congress mean?

The Congress has appointed two separate general secretaries for Uttar Pradesh: Priyanka Gandhi Vadra and Jyotiraditya Scindia will be in charge of East and West Uttar Pradesh respectively. According to senior Congress leaders, East Uttar Pradesh accounts for 42 Lok Sabha seats from the sub-regions of Avadh and Purvanchal. West Uttar Pradesh includes Bundelkhand, Ruhelkhand and western parts of the state and accounts for the remaining 38 Lok Sabha seats in Uttar Pradesh.

Lok Sabha Elections dates announced: Polls to be held from April 11 in 7 phases, result on May 23

The Election Commission of India (ECI) announced the dates for Lok Sabha and some state Assembly elections. Chief Elections Commissioner (CEC) Sunil Arora said that the elections for the 17th Lok Sabha will be held in seven phases. The elections will start on April 11 and continue till May 19. The counting will be held on May 23. Nearly 90 crore voters will be eligible to vote for 543 Lok Sabha constituencies across the country.

India bans Boeing 737 Max aircraft: All you need to know

Late last evening India finally joined the growing number of countries grounding Boeing 737 MAX 8 planes following two deadly plane crashes killing 346 people in the space of five months, both involving this aircraft model. Announcing the development on Twitter, India's aviation watchdog Directorate General of Civil Aviation had added that these planes "will be grounded till appropriate modifications and safety measures are undertaken to ensure their safe operations".

BJP denies Lok Sabha poll tickets to veterans in major makeover bid

NEW DELHI: The ruling Bharatiya Janata Party (BJP) has denied tickets to veterans leaders, who were instrumental in building the party, as part of a major makeover in the run-up to the Lok Sabha elections. Soon after coming to power in 2014, the BJP leadership under Prime Minister Narendra Modi and party president Amit Shah decided that senior leaders aged 75 years, or more, will not hold any public office.

Coffee Day Enterprises falls 4% on agreement to sell stake in Mindtree

Shares of Coffee Day Enterprises, the parent company of the Coffee Day Group, which owns Cafe Coffee Day, tumbled over 4 per cent on Tuesday after the promoter of the company sold his entire stake of Mindtree to Larsen & Toubro. "Coffee Day Trading and V.G. Siddhartha, promoter of the company, along with certain other parties have signed a definitive agreement to sell their entire stake in Mindtree Ltd to Larsen & Toubro Limited for a consideration not exceeding Rs 3,269 crore.

Abhinandan: Captured Indian pilot handed back by Pakistan

Wing Commander Abhinandan Varthaman was handed over to Indian officials on Friday at the only legal border crossing with Pakistan. Minutes earlier, the pilot said on Pakistani TV that he was "very impressed" by the Pakistan army. On Thursday Pakistan's Prime Minister Imran Khan said the pilot's release was a "peace gesture" to India. India and Pakistan - both nuclear powers - claim all of Kashmir, but each controls only parts of it.

Mehul Choksi, accused in PNB fraud, surrenders Indian citizenship in favour of Antigua and Barbuda

Wanted diamond trader Mehul Choksi has surrendered his Indian passport, sources confirmed on Monday. The confirmation came a year after Mr. Choksi and his nephew, Nirav Modi, left India, just before the major financial scam involving them and the Punjab National Bank (PNB) came to light. Mr. Choksi was subsequently located in the Caribbean island of Antigua. "Mehul Choksi has surrendered his Indian passport to the High Commission in Guyana.

'Mission Shakti': India's first anti-satellite missile system that destroyed a LEO satellite

NEW DELHI: Giving an "important message", Prime Minister Narendra Modi on Wednesday announced that India has successfully tested its first anti-satellite missile system, code-named 'Misson Shakti'. "India has entered its name as an elite space power. An anti-satellite weapon ASAT, successfully targeted a live satellite on a low earth orbit (LEO)," PM Modi said. The Prime Minister also stated that shooting down a LEO satellite is a rare achievement and was completed successfully within three minutes of launch.

Vijay Mallya becomes first person to be declared a 'fugitive economic offender' under new law

A special court in Mumbai declared absconding liquor baron Vijay Mallya a fugitive economic offender (FEO) on a plea of the Enforcement Directorate. Mallya has become the first businessman to be declared EFO under the provisions of the new Fugitive Economic Offenders Act which came into existence in August last year. The ED had requested the Prevention of Money Laundering Act (PMLA) court that Mallya, who is currently in the UK, be declared a fugitive and his properties.

How India's first air strike in Pakistani territory since 1971 unfolded

India took down the largest Jaish-e-Mohammad terror training camp in Pakistan in a meticulously planned early morning air raid on Tuesday, terming it a "non-military, preemptive" strike based on credible intelligence that terrorists based in the camp were being trained for another suicide bombing in India. The strikes — India's first such air raid into Pakistan since the 1971 war — targeted the Balakot training camp located in Khyber Pakhtunkhwa province, beyond Pakistan-occupied Kashmir.

Omar for assembly polls in JK immediately after LS election, does not favour coalition govt

National Conference leader Omar Abdullah favours early Assembly elections in Jammu and Kashmir and has expressed the hope that the people of the state will give mandate for a single party rule, instead of a coalition government in the state as has been witnessed since 2002. In an interview to PTI, the former chief minister said assembly election in the state can be held in a three-to-five week period.

L&T prepares for hostile takeover of Mindtree

Mumbai: Larsen and Toubro Ltd (L&T), which has been in talks to buy Cafe Coffee Day founder V.G. Siddhartha's stake in Mindtree Ltd, is set to sign a binding agreement to close the deal, two people directly aware of the development said. The deal, which is likely to be announced in the weeks ahead, could trigger a hostile takeover bid, leading to an open offer by L&T, India's largest engineering company, to increase its stake to 51%.

Busting 5 concerns about Congress' NYAY scheme

On 25 March, Congress president Rahul Gandhi announced the Nyuntam Aay Yojana, or NYAY scheme. The plan is to give ₹6,000 every month to the bottom 20% of the population of around 5 crore families or 25 crore individuals. Gandhi's proposal is not that of universal basic income (UBI), of which there has been a lot of talk in the recent past. UBI is basically a small amount of money paid every month to every citizen of a country, without any terms and conditions.

Rahul Gandhi likely to contest from south too

Congress president Rahul Gandhi is likely to enter the fray from a Lok Sabha constituency in the south, party sources told The Hindu on Saturday. The Congress units of Kerala, Tamil Nadu, Andhra Pradesh and Karnataka have strongly urged Mr. Gandhi to contest from their States, but he has not taken a decision yet, multiple sources said. Party leaders in Kerala were vocal on Saturday about their request to Mr. Gandhi that he contest from Wayanad in north Kerala.

Shaktikanta Das takes charge as 25th Governor of the RBI

Newly appointed Reserve Bank of India (RBI) governor Shaktikanta Das took charge today after government selected him to replace Urjit Patel as the head of India's monetary authority. Urjit Patel abruptly resigned as the head of India's central bank Monday citing personal reasons amid tensions between the government and the RBI over issues related to governance and autonomy of the central bank. Having worked equally at ease under three different finance ministers -- P Chidambaram.

RBI repo rate cut: How much will your home loan EMIs reduce?

The six-member Monetary Policy Committee (MPC), headed by RBI Governor Shaktikanta Das, voted to reduce the repo rate by 25 basis points (bps) to 6 per cent from 6.25 per cent earlier. This is the second consequent rate cut and with this development, those shopping around for home loans, car loans are likely to get a cheaper deal soon while the EMIs on some of your existing loans may come down. Of course, that's assuming banks decide to pass on the benefits of the lowered rates to the end consumers.

General election 2019 live | Phase 1 polling concludes, Tripura registers highest voter turnout at 81.8%

The first phase of the general election began on April 11 with voters exercising their franchise in 91 of the 543 constituencies spread across 20 States and Union Territories - Andhra Pradesh, Telangana, Uttarakhand, Sikkim, Arunachal Pradesh, Meghalaya, Mizoram, Nagaland, Andaman and Nicobar Islands and Lakshadweep. New Delhi: India's Silicon Valley, Bengaluru is the largest office market in India and the biggest in the Asia-Pacific (APAC) region. According to property consultancy CBRE, last year, it has absorbed 11.6 million sqft of office space on a net basis, taking account of vacated space, as compared to Tokyo's seven million, Shanghai's six million, Hong Kong's three million, Beijing's 2.5 million, Singapore's 1.6 million, Sydney's 1.4 million and Seoul's 1.3 million.

Bank of Baroda to become larger than ICICI Bank from 1 April

New Delhi: Powered by the business of Dena Bank and Vijaya Bank, Bank of Baroda will become larger than ICICI Bank from 1 April following completion of the amalgamation process of three state-run banks. After State Bank of India (SBI) and HDFC Bank, with businesses of ₹ 45.85 trillion and ₹ 15.8 trillion respectively, ICICI Bank (₹ 11.02 trillion) is the third largest commercial bank now,. Based on share swap ratio, the total business of the merged entity will be ₹ 15.4 trillion, only a notch below HDFC Bank but above ICICI Bank.

For more connectivity, need right-of-way, govt support: COAI

The Indian telecom industry has erected five lakh additional mobile towers in the last two years between November 2016 and October this year, taking the total number of base transceiver stations (BTSs) to over 20 lakh. The telecom industry has also been closely working with the government in building a well-entrenched communication infrastructure and till date has invested ₹10.44 lakh crore, said the Cellular Operators Association of India (COAI) in a release on Thursday.

India to retain top position in remittances with \$80 billion: World Bank

India will retain its position as the world's top recipient of remittances this year with its diaspora sending a whopping USD 80 billion back home, the World Bank said in a report Saturday. India is followed by China (USD 67 billion), Mexico and the Philippines (USD 34 billion each) and Egypt (USD 26 billion), according to the global lender. With this, India has retained its top spot on remittances, according to the latest edition of the World Bank.

Jamia Millia gets its first woman V-C

Professor Najma Akhtar of the National Institute of Educational Planning and Administration, New Delhi was appointed as the Vice-Chancellor of Jamia Millia Islamia University on Thursday. "In exercise of powers conferred under statutes of JMI Act, 1988, the President of India, in his capacity as the Visitor JMI, has been ...pleased to appoint Professor Najma Akhtar as the V-C of JMI, New Delhi, for a period of five years from the date on which she enters upon her office or until she attains the age of 70 years, whichever is earlier,".

SoftBank's top executive Alok Sama to leave firm

BENGALURU: Alok Sama, a St Stephen's College graduate, who has helped SoftBank founder Masayoshi Son steer his biggest deals like the \$32-billion purchase of UK's ARM Holdings and the \$59-billion merger of US telcos Sprint and T-Mobile, is leaving the firm after a five-year stint, according to two sources. The 56-year-old executive, who was also closely involved in SoftBank's early India investments into online marketplace Snapdeal and ride-hailing major Ola, will continue to be a senior adviser even as he leaves his post of president.

How to link PAN with Aadhaar

The Supreme Court (SC) has allowed linking of PAN with Aadhaar while reading out its verdict on the constitutional validity of Aadhaar. The apex court also said that Aadhaar is a must to file income tax returns (ITR) and to apply for a new PAN. As per Central Board of Direct Taxes (CBDT) press release dated March 31, 2019, the deadline to link PAN with Aadhaar has been extended to September 30, 2019.

India successfully launches EMISAT satellite

India scripted history by successfully launching EMISAT, a military satellite, and 28 foreign nano satellites on-board its polar rocket from here Monday, in a complex mission which marked many a first for ISRO. The rocket, PSLV-C45, in its 47th mission, injected the 436 kg EMISAT, aimed at electromagnetic measurement, and 28 co-passenger satellites belonging to Lithuania, Spain, Switzerland and the US, into their designated orbits, ISRO said.

Those raided include Nath's former Officer on Special Duty Pravin Kakkar, former advisor Rajendra Miglani and executives linked to his brother-in-law's firm Moser Baer and his nephew Ratul Puri's company, Hindustan Powerprojects Pvt Ltd.

Shatrughan Sinha joins Congress, fielded from Patna Sahib against BJP's Ravi Shankar Prasad

Actor-turned-politician Shatrughan Sinha joined the Congress on Saturday at the party headquarters in New Delhi. He was with the BJP till recently. Hours later, the Congress announced his candidature for the Patna Sahib Lok Sabha constituency in Bihar to take on Union Minister Ravi Shankar Prasad. Congress general secretary K.C. Venugopal, party spokesperson Randeep Surjewala and in charge of party's Bihar unit Shaktisinh Gohil welcomed Mr. Sinha into the party fold.

Rajnish Kumar to replace Arundhati Bhattacharya as SBI chief

MUMBAI: State Bank of India managing director Rajnish Kumar will succeed Arundhati Bhattacharya as chairman of the country's largest bank. "I look forward to serving the bank to the best of my abilities along with the support of all my colleagues spread across the globe," Kumar said in a statement on Wednesday. The Appointments Committee of the Cabinet approved the appointment of Kumar for three years from October 7.

Jet Airways lenders considering interim funding of ₹500 crore: PNB MD

ew Delhi: A consortium of banks is considering an interim funding of ₹500 crore for debt-laden Jet Airways (India) Ltd, but a final decision is yet to be taken, Punjab National Bank managing director Sunil Mehta said on Friday. PNB is part of the lenders' consortium, led by State Bank of India (SBI), that has extended loans to the airline. The consortium is looking at the entire process and something is being worked out. "Of course, (the) consortium is in favour (of interim funding).

Supreme Court quashes RBI circular on debt resolution

NEW DELHI: The Supreme Court struck down a Reserve Bank of India (RBI) circular that gave defaulting companies 180 days to agree on a resolution plan with lenders or be taken to bankruptcy court to recover debt of Rs 2,000 crore and above. The bench said the February 12, 2018, circular was beyond the scope of the RBI's powers. "The impugned circular will have to be declared as ultra vires as a whole, and be declared to be of no effect in law,".

ICC World Cup 2019: India announces squad, Risabh Pant misses out

New Delhi: Dinesh Karthik has beaten Rishabh Pant in the race to become the second wicketkeeper in the Indian team for the upcoming World Cup in England and Wales. The five-man national selection committee led by M.S.K. Prasad, met in Mumbai on Monday and picked the 15-member squad. Vijay Shankar goes to the showpiece event as the number four batsman and Ravindra Jadeja has been picked as the third spinner ahead of a fourth pacer. KL Rahul joins in as the back-up opener.

Lok Sabha elections 2019: Details of 95 seats that go to polls in Phase 2

The second phase of the seven-phase Lok Sabha elections 2019 was held in 95 constituencies across 13 states and Union Territories (UTs) on Tuesday. As many as 1,644 candidates from across various parties and independent ones were in the fray for these 95 seats. The 2019 Lok Sabha polls began on April 11 with the first phase of voting across 91 seats dispersed across 20 states and Union Territories.

Vodafone Idea, a new leader in the Indian telecom space

Idea Cellular and Vodafone India have completed their merger process and officially started operations as Vodafone Idea with a subscriber base of more than 408 million. The merged entity has pipped Bharti Airtel (344.88 million users in July) to claim the top spot. The company will also have the largest voice network with over 2 lakh GSM sites to cover 1.2 billion subscribers, or 92 per cent of the population. Its spectrum portfolio will comprise 1850 MHz and a number of broadband carriers, providing 2G, 3G and 4G services.

Reliance in talks to acquire iconic British toy brand Hamleys for up to ₹350 crore

Reliance Industries Ltd (RIL) is in talks to acquire British toy retailer Hamleys in a bid to expand its global footprint in the retail category. According to sources, the company is in advanced talks with the iconic British brand, founded in 1760, and might make an announcement soon. The acquisition could be in the range of ₹250-₹350 crore, said another source. At the time of going to press, BusinessLine had not received a response from Hong Kong-based C Banner International, which owns Hamleys.

Govt targets IRCTC, IRFC IPOs by Sept, to raise Rs 1,500 crore

New Delhi: The government is targeting to raise about Rs 1,500 crore from initial public offerings (IPOs) of two railway companies -- IRCTC and IRFC -- by September, an official said. The finance ministry earlier this year initiated the process of launching an IPO of Indian Railway Finance Corporation (IRFC) but the company has told the railway ministry that their borrowing cost will go up if it gets listed, the official said. A final call on this would be taken by the Union Cabinet.

Reliance eyes higher valuation for refining arm in likely Aramco deal

Mumbai: Mukesh Ambani's Reliance Industries Ltd (RIL) has sought a higher valuation for its refining and petrochemicals business as it considers selling a minority stake to Saudi Arabia's state energy group, Saudi Aramco, said two officials directly aware of the development, requesting anonymity. On Wednesday, The Times of India reported that Saudi Aramco is in talks with RIL to buy up to a 25% stake in its refining and petrochemicals business.

Maruti Suzuki plans to stop producing BS-IV models by Dec 2019

NEW DELHI: Automobile major Maruti Suzukis Chairman R.C. Bhargava on Wednesday said it plans to stop manufacturing Bharat Stage (BS)-IV compliant cars by the end of 2019. The company's decision is in line with the Supreme Court's order stating that no BS-IV vehicle should be sold in the country from April 1, 2020 as the BS-VI emission norms would come into force. "Broadly, the production of BS-VI will largely come to a stop by December 2019," Bhargava said here during a media interaction.

Jet Airways may ground operations as banks refuse emergency funds

With the lenders rejecting an lifeline of ₹400 crore on April 17 Jet Airways, which has been on a wing and prayer since January, is left with no other option but to ground operations at least temporarily. Since the March 25 resolution to infuse ₹1,500 crore into the airline is yet to fructify, the once leading airline has been defaulting on payments, forcing its lessors to retake almost all its planes and was operating just about six planes as of April 16.

Apple and Qualcomm settle a feud over patents

The courtroom battle in San Diego was supposed to last for weeks, if not months. It was over on the first day, April 16th. Evan Chesler, a lawyer for Qualcomm, a big chip designer, had only a few minutes left in his riposte to Ruffin Cordell, who represented Apple, a hardware giant, when it emerged that the two firms had agreed to a settlement. This included a one-off payment from Apple to Qualcomm and the decision to "dismiss all litigation between the two companies worldwide".

The committee of creditors to Gitanjali Gems, promoted by fugutive Mehul Choksi, has decided to liquidate the company to recover ₹ 12,558 crore it owes to 31 banks and financial institutions. Choksi along with diamantaire Nirav Modi, are on the run since early last year after they misused credit facilities of banks and defaulted on loan repayment. Almost all the investigative agencies of the country are probing the multi-million scam perpetrated by Modi and Choksi together.

PE fund AION fully exits Varun Beverages, walks away with handsome return

AION, a joint venture between Apollo Global Management and ICICI Venture, had invested \$90 million in Varun Beverages. Private equity fund AION has decided to completely exit the Ravi Jaipuria-promoted Varun Beverages, bottlers for beverage giant Pepsi. This comes nearly three and a half year after it invested \$90 million (Rs 625 crore according to Wednesday's exchange rate) in the company.

FATF grey listing to take its toll on Pakistan economy

NEW DELHI: Pakistan's economy will be adversely impacted following Friday's decision by the Financial Action Task Force (FATF) to put the country in the 'grey list' for failing to fulfil obligations to prevent terror financing. The country may suffer a risk downgrade by multilateral lenders such as IMF, World Bank, ADB and also a reduction in risk-rating by Moody's, S&P and Fitch, according to an expert on Pakistan economy.

Greater efforts will be needed to reduce fiscal deficit: IMF

The International Monetary Fund (IMF) on Tuesday said that greater efforts will be needed to reduce the fiscal deficit as the interim budget envisages a slower pace of fiscal consolidation than previously planned. "The interim budget envisages a slower pace of fiscal consolidation than previously planned, delaying the time to reach the medium-term central-government debt target of 40 percent of GDP," Ranil Salgado, IMF mission chief for India told PTI.

Goodricke parent Camellia becomes the world's largest private tea producer

Its exit from Rwanda further trimmed around 5 million kg, taking its global output to around 80 million kg. In 2017-18, it had produced 118 million kg of tea.

RBI reserves: Shaktikanta Das says Jalan panel to submit report shortly

Mumbai: In its first asset sale since going bust last year, Infrastructure Leasing and Financial Services Ltd (IL&FS) on Monday said it has agreed to sell its 874 megawatts (MW) operational wind energy portfolio to state-run gas utility GAIL (India) Ltd for ₹4,800 crore. The sale will close in three weeks, IL&FS said in a statement on Monday. Significantly, GAIL's offer of ₹4,800 crore at 100% enterprise valuation implies that the accumulated debt of ₹3,700 crore on the wind power special purpose vehicles (SPVs) will be fully repaid.

MUMBAI: SWIFT India Domestic Services, the local unit of SWIFTNSE 4.95 % (Society for Worldwide Interbank Financial Telecommunication) global that facilitates international payments functions for banks, has appointed Arundhati Bhattacharya, former chairman of State Bank of IndiaNSE 0.72 %, as its chairman. hattacharya, who had served nearly four decades at the State Bank of India, would succeed MV Nair who retires after about five years of heading SWIFT India.

NIA arrests Yasin Malik inside Delhi court, questions Mirwaiz

The National Investigation Agency (NIA) on Wednesday arrested separatist leader and JKLF chief Yasin Malik after a special court granted his 13-day custody to the probe agency. According to an NIA spokesman, Mr. Malik, chief of the banned group, the Jammu and Kashmir Liberation Front, and a constituent of the All Parties Hurriyat Conference (APHC), was arrested on Wednesday in the alleged J&K "terror funding" case.

BEIJING: China said Friday it was ready to hold a Wuhan-style summit meeting with India this year to improve ties, notwithstanding the differences over the trillion-dollar Belt and Road Initiative in which the China-Pakistan Economic Corridor (CPEC) is a flagship project. Addressing a media conference here ahead of the Belt and Road Forum (BRF) being held from April 25-27 to showcase China's trillion-dollar Belt and Road Initiative (BRI).

Not gold but Indian wrestlers bag 5 medals on 2nd day of Asian Wrestling Championships

Indian wrestlers reaped a rich-harvest of five medals in men's freestyle events but a gold medal eluded them on the second day of the Asian Championships here on Wednesday. All the five wrestlers who competed on Wednesday won a medal each but none could add a gold on the second day after Bajrang Punia clinched a yellow metal in 65kg men's freestyle on Tuesday.

YouTube CEO does damage control after advertisers flee over pedophilia scandal

US likely to end sanction waiver for India and four other countries on Iran oil

The Trump administration is poised to tell five nations, including allies Japan, South Korea and Turkey, that they will no longer be exempt from US sanctions if they continue to import oil from Iran, officials said Sunday. Secretary of State Mike Pompeo plans to announce on Monday that the administration will not renew sanctions waivers for the five countries when they expire on May 2, three US officials said. The others are China and India. It was not immediately clear if any of the five would be given additional time to wind down.

Sri Lanka Easter blasts: 6 JD(S) workers among 8 Indians confirmed dead

At least eight Indians are confirmed to have been killed in the serial suicide blasts across churches and luxury hotels in Sri Lanka, that left 290 dead and several injured on Easter Sunday, officials said on Monday. The victims include six Janata Dal (S) workers from Karnataka, who were in Colombo on a vacation and staying at the Shangri-La Hotel, and a woman from Kerala, P.S. Raseena, who was identified by Kerala Chief Minister Pinarayi Vijayan. Of four persons of another group from Karnataka.

Eiffel Tower Dims Lights to Pay Tribute to Victims of Easter Sunday Attacks in Sri Lanka

The glorious Eiffel Tower usually lights up the Paris skyline as the night falls. Yemen war: Trump vetoes bill to end US support for Saudi-led coalition

Mr Trump described the resolution as an "unnecessary" and "dangerous" attempt to weaken his constitutional powers. It is only the second time Mr Trump has used his presidential veto since he took office in 2017. Opposition in Congress to his policy on Yemen grew last year after Saudi agents killed the journalist Jamal Khashoggi at the Saudi consulate in Istanbul. The resolution passed the House of Representatives in April and the Senate in March, the first time both chambers had supported a War Powers resolution.

Vote counts from five independent survey groups showed Widodo with a clear lead over Subianto, a general during the era of the Suharto military dictatorship who warned Indonesia would fall apart without his strongman leadership.

U.S. Treasury official David Malpass named World Bank President

David Malpass, a top U.S. Treasury official in Trump administration, was on April 5 unanimously selected as the new President of the World Bank. The World Bank's 25-member executive board unanimously approved 63-year-old Malpass, who is currently Under Secretary of Treasury for International Affairs, as the development lender's 13th President for a five-year term beginning April 9, according to a statement.

Stratolaunch: 'World's largest plane' lifts off for the first time

The world's largest aeroplane by wingspan has taken flight for the first time. Built by Stratolaunch, the company set up by the late Microsoft co-founder Paul Allen in 2011, the aircraft is designed to act as a flying launch pad for satellites. The idea is to fly the plane to 10 km (6.2 miles) high before releasing satellites into orbit. Its 385 ft (117 m) wingspan is longer than an American football field.

Notre-Dame: Massive fire ravages Paris cathedral

A major fire has engulfed the medieval cathedral of Notre-Dame in Paris, one of France's most famous landmarks. The 850-year-old Gothic building's spire and roof have collapsed but the main structure, including the two bell towers, has been saved, officials say. Firefighters are still working to contain the blaze as teams try to salvage the artwork stored inside. President Emmanuel Macron called it a "terrible tragedy". The cause of the fire is not yet clear.

The medal, awarded to kings presidents and heads of states, was conferred upon Modi for boosting relations between the Emirates and India. Previously, Russian President Vladimir Putin, Chinese President Xi Jinping have also been conferred with the honour. Julian Assange: Wikileaks co-founder arrested in London

Assange took refuge in the embassy in 2012 to avoid extradition to Sweden over a sexual assault case that has since been dropped. At Westminster Magistrates' Court on Thursday he was found guilty of failing to surrender to the court. He now faces US federal conspiracy charges related to one of the largest ever leaks of government secrets. The UK will decide whether to extradite Assange, in response to allegations by the Department for Justice that he conspired with former US intelligence.

Omar al-Bashir: Sudan's ousted president

When he seized power, Sudan was in the midst of a 21-year civil war between north and south. Although his government signed a deal to end that conflict in 2005, another one was breaking out at the same time - in the western region of Darfur, where Mr Bashir is accused of organising war crimes and crimes against humanity by the International Criminal Court (ICC). Despite an international arrest warrant issued by the ICC, he won consecutive elections in 2010 and 2015.

Ghosn's Fate May Hang on Complex Financial Web in Middle East

Soon after Carlos Ghosn was taken into custody last fall, kicking off a bizarre legal odyssey that's transfixed the automotive world, some wondered whether the financial crimes he'd been accused of were serious enough to warrant the shocking arrest of Nissan Motor Co.'s fabled chairman. Turns out that was just the opening act. The initial arrest last November -- over what some viewed as a relatively minor charge of understating compensation.

This is a major setback to Indian efforts to proscribe the Pulwama mastermind under the 1267 Al Qaeda Sanctions Committee of the UN Security Council (UNSC).

Mohammed Ishtaye sworn in as new Palestinian PM

New Palestinian Prime Minister Mohammed Ishtaye and his cabinet members were sworn in before President Mahmoud Abbas at his headquarters in the West Bank city of Ramallah on Saturday, the official television reported. The 18th Palestinian government since the establishment of the Palestinian Authrity in 1995 was sworn in according to a presidential decree issued by Abbas, Xinhua news agency reported.

Lebanon sets new Guinness World Record

Lebanon's capital Beirut has set a new Guinness World Record for the number of national flags raised in a city for 24 hours. The Beirut Alive Association in the national capital on Sunday raised a total of 26,852 Lebanese flags breaking New York's Waterloo record of 25,599 flags, Xinhua reported. "I came here to adjudicate the record title for the most national flags displayed in one city in 24 hours. I am here to make sure that all guidelines of Guinness World Record have been achieved.

Sri Lanka attacks: Face coverings banned after Easter bloodshed

President Maithripala Sirisena said he was using an emergency law to impose the restriction from Monday. Any face garment which "hinders identification" will be banned to ensure security, his office said. Muslim leaders criticised the move. The niqab and burka - worn by Muslim women - were not specifically named. The move is perceived as targeting those garments, however. Sri Lanka remains on high alert eight days after Islamist attacks that hit churches and hotels.

WHO releases guidelines on how countries can use digital health technology

The World Health Organization (WHO) on April 17, 2019, released new recommendations on 10 ways that countries can use digital health technology, accessible via mobile phones, tablets and computers, to improve people's health and essential services. The recommendations are a result of a two-year-long research by the WHO on digital technologies, including consultations with global experts, so that such tools may be used for maximum impact on health systems and people's health.
