Justice G. Rohini Commission submits report on sub-categorisation of OBCs after 6 years

The Justice G. Rohini-headed Commission for the sub-categorisation of Other Backward Classes (OBC) caste groups on July 31 submitted its report on the issue to the Ministry of Social Justice and Empowerment, nearly six years after the Union government first assigned the task to it — a task that was initially meant to be finished in 12 weeks. The Commission's report was submitted on the last day of its functioning on Monday, after it had received up to 14 extensions from the government in the last six years.

Reserve Bank of India (RBI): 88% of ₹2,000 notes back at banks up to July 31, 2023

The RBI on Tuesday said about Rs 3.14 trillion or 88% of the total Rs 2,000 bank notes in circulation as on May 19 have been returned by the public to banks as at the end of July 31. About Rs 42000 crore in the form of Rs 2,000 bank notes were still in circulation as of July 31, the RBI said. Data collected from major banks, RBI said, indicates that out of the total banknotes in Rs 2,000 denomination received back from circulation.

India's top 50 wilful defaulters owed banks as much as ₹87,295 crore as of March 31 2023

The finance ministry on Tuesday said top 50 wilful defaulters including Gitanjali Gems Limited, Era Infra Engineering Limited, REI Agro Limited, and ABG Shipyard Limited owe Rs 87,295 crore to banks and financial institutions. Of this, top 10 wilful defaulters owe Rs 40,825 crore to schedule commercial banks (SCBs), Minister of State for Finance Bhagwat Karad said in a written reply in Rajya Sabha.

India's gross revenues from the Goods and Services Tax (GST) hit a threemonth high to cross ₹1.65 lakh crore in July

India collected Rs 1.65 lakh crore Goods and Services Tax (GST) for the month of July, registering growth of 11% from a year earlier The GST collections crossed the Rs. 1.60 lakh crore mark for the fifth time. During the month, the revenues from domestic transactions (including import of services) are 15% higher than the revenues from these sources during the same month last year, the finance ministry said in a statement.

Supreme Court: President retains power to scrap Article 370

The Supreme Court on August 2 raised the question whether the President's power to declare inoperative Article 370 of the Constitution, which granted special status to Jammu and Kashmir, will not continue to hold the field after the dissolution of the erstwhile State's Constituent Assembly on January 26, 1957. Clause (3) of Article 370 gave the President power to notify the Article "inoperative" or modify it.

Government e-Marketplace registers highest ever Gross Merchandise Value of more than ₹ 2 lakh crore in FY 2022-23

The Government e-marketplace (GeM) registered its highest-ever Gross Merchandise Value of Rs 2,01,113 crore during the financial year 2022-23. GeM aims to bring transparency, efficiency, and fairness to the Government procurement process. It benefits stakeholders in several ways, allowing them to participate in a fair and equitable manner. According to the government, it helps encourage fair and equitable participation from all stakeholders in the Government process.

GST Council sticks to its plan to collect 28% tax on online gaming

The GST Council on August 2 blinked a little on technicalities and kept the door open for a review down the road, but stuck to its earlier decision to impose a 28% levy on the full face value of bets placed on online gaming, casinos and horse racing, with an eye on implementing it from October 1. Finance Minister Nirmala Sitharaman, who chaired the Council's meeting, said the Centre would now strive to amend the Goods and Services Tax (GST) law in Parliament's current session itself to enable the implementation of the levy, despite dissent from Sikkim and Goa over the modalities of the tax for casino users.

insurance regulator IRDAI lets insurers hold HDFC investments till maturity

Insurance regulator IRDAI has clarified that bonds/debentures held by insurers in the erstwhile HDFC under the 'housing and infrastructure' category as on April 4, 2022, when the merger of the mortgage lender with HDFC Bank was announced, will be treated as investments in the same category till maturity of the respective instruments. It also exempted the insurers from complying with the single investee equity exposure norms, under IRDAI regulations.

BIS signs MoU with 35 institutions for collaboration in standardisation

The Bureau of Indian Standards (BIS) on Saturday said it has signed a Memorandum of Understanding (MoU) with 35 institutions for fostering collaboration in standardisation and conformity assessment. The National Standards Body will also explore setting up of Centre of Excellence for Standardisation in partnership with these institutions. The institutions included prominent NITs, government, and private engineering colleges from different states across the country.

EPFO to appoint actuary to get consultancy for insurance, pension scheme

The Employees' Provident Fund Organisation (EPFO) is in the process of appointing an actuary firm for the purpose of providing consultancy services to it on matters related to insurance and staff pension cum gratuity. The statutory body under the Ministry of Labour & Employment had issued a request for proposal (RFP) to appoint an actuary or an actuarial firm to carry out the annual valuation of the Employees Deposit Linked Insurance (EDLI) scheme fund.

MeiTY launches the Indian Web Browser Development Challenge and plans on launching its own internet browser

The Ministry of Electronics and Information Technology (MeitY) launched the Indian Web Browser Development Challenge (IWBDC) on Wednesday, according to a release. The IWBDC is an open challenge competition that seeks to inspire and empower technology enthusiasts, innovators, and developers from all corners of the country to create an indigenous web browser.

Axis Bank to infuse ₹16.12 billion to raise stake in Max Life

Axis Bank on Wednesday said it will raise its stake in insurer Max Life to 16.2% from 9.99% by infusing 16.12 billion rupees (\$194.6 million) through a preferential allotment of shares. Axis Bank along with its entities acquired a 12.99% stake in Max Life in 2021, and through this new investment, they will own 19.02% in the insurer. Max Financial Services, the holding company of Max Life, will hold about 80.98% in the insurer.

Reserve Bank of India (RBI) proposes incorporating Artificial Intelligencepowered conversational features in UPI

Reserve Bank of India (RBI) Governor Shaktikanta Das, while announcing the central bank's monetary policy committee has kept the repo rate unchanged, on Thursday said the central bank has proposed to use conversational payments on unified payments interface (UPI) through artificial intelligence (AI). Governor Das proposed to launch an innovative payment mode viz., "Conversational Payments" on UPI, that will enable users to engage "in a conversation with an AI-powered system to initiate and complete transactions in a safe and secure environment."

RBI keeps repo rate unchanged at 6.5 percent; Projects real GDP growth for current fiscal at 6.5 percent

ON EXPECTED lines, the Reserve Bank of India (RBI) Thursday left the repo rate unchanged at 6.5 per cent for the third time in a row amid concerns over rise in inflation. The six-member Monetary Policy Committee (MPC) revised its FY'24 consumer price index (CPI) inflation projection to 5.4 per cent from an estimate of 5.1 per cent announced in June, even as it retained its forecast for real gross domestic product (GDP) growth at 6.5 per cent.

Bank of Maharashtra cuts home and car loan interest rates

Bank of Maharashtra (BoM) has cut its home loan interest rate by 10 basis points (bps) to 8.50 per cent and car loan interest rate by 20 basis points to 8.70 per cent with effect from August 14. Currently, the Pune-headquartered public sector bank offers home loans and car loans at 8.60 per cent and 8.90 per cent, respectively. The bank has also waived processing fees on home and car loan schemes.

RBI selects McKinsey and Company, Accenture Solutions to use AI and ML to improve regulatory super

Mumbai: The Reserve Bank has selected global consultancy firms McKinsey and Company India LLP and Accenture Solutions Pvt Ltd India to develop systems using artificial intelligence and machine learning for its supervisory functions. The RBI is looking to extensively use advanced analytics, artificial intelligence and machine learning to analyse its huge database and improve regulatory supervision over banks and NBFCs. For this purpose, the central bank plans to hire external experts.

RBI issues fresh guidelines asking banks and NBFCs not to levy penal interest on borrowers in case of default

Reserve Bank of India (RBI) has issued fresh guidelines to the Regulated Entities (REs) such as commercial and other banks, Non-Banking Finance Companies (NBFCs) and other lenders to ensure reasonableness and transparency in disclosure of penal interest. This follows findings that many REs are using penal rates of interest, over and above the applicable interest rates, in case of defaults/non-compliance by the borrower with the terms on which credit facilities were sanctioned.

The strike on Novorossiysk — which halted maritime traffic for a few hours — marks the first time a commercial Russian port has been targeted in the nearly 18-month-old conflict.

Former Pakistan Prime Minister Imran Khan was arrested after he was found guilty in the state gifts case

Former Pakistan Prime Minister was arrested in Lahore on Saturday after a trial court sentenced him to three years in prison in Toshakhana case, news agency Reuters reported. The sentence relates to a probe conducted by the election commission, which found the expremier guilty of illegally selling state gifts worth more than 140 million Pakistani rupees (\$635,000) during his tenure from 2018 to 2022.

Moody's downgrades credit ratings of several small to mid-sized U.S. banks

Shares of banks in the US declined sharply on Tuesday after ratings agency Moody's downgraded several US lenders and said it may downgrade other major lenders. Moody's Investors Service cut credit ratings for 10 small and midsize US banks and placed some major lenders including M&T Bank Corp., Webster Financial Corp., BOK Financial Corp., Old National Bancorp, Pinnacle Financial Partners Inc., and Fulton Financial Corp.

Anwaar ul Haq Kakar was sworn in as Pakistan's caretaker Prime Minister

Former Pakistani Senator Anwaar-ul-Haq Kakar was sworn in on Monday as the country's prime minister to head a caretaker government that will oversee parliamentary elections during one of the country's worst economic crises. Kakar, who is comparatively new to politics and is close to the powerful military, has represented his Baluchistan province in the Senate since 2018.

Luna 25, Russia's first lunar mission in 47 years, crashes into the moon: Roscosmos

The craft was due to be the first ever to land on the Moon's south pole, but failed after encountering problems as it moved into its pre-landing orbit.



Chinese smartphone brand Honor will relaunch in India through a licensing deal with a local company

HonorTech will relaunch the Honor brand of smartphones in the country in September with plans to initially invest Rs 1,000 crore in the business, a senior company official said. For the relaunch, HonorTech is going to work under a licensing deal with a Chinese smart devices company Honor, in India. HonorTech CEO Madhav Sheth told PTI that the company will aim to garner 4-5 per cent market share in terms of volume by end of next year, which will translate to a revenue of Rs 10,000 crore for the company.

US 's FDA approved first respiratory syncytial virus vaccine for use in women during pregnancy to protect baby

The United States on Monday became the first country to approve a vaccine for pregnant women that prevents severe disease caused by Respiratory Syncytial Virus (RSV) in their babies. The Pfizer shot, which was already approved for use in older adults, has now been greenlighted for use as a single injection from 32 through 36 weeks of pregnancy, to protect infants from birth through six months, a statement by the Food and Drug Administration said.

Mr. Srettha Thavisin has been elected as the Prime Minister of Thailand

The newly selected Prime Minister of Thailand, former real estate tycoon Srettha Thavisin, is starting his political journey on shaky ground. Just weeks before the May 14 Thai national election, which resulted in three months of gridlock, the 61-year-old political neophyte had told the Voice of America: "I don't believe in military coups". As his Pheu Thai party fought the election with a clear stance against military rule, the ex-property mogul candidly declared while campaigning how he would turn down the Prime Ministerial post if the military was a part of the government.

Meta Platforms on Thursday said it would release an artificial intelligence (AI) model designed to assist in writing computer code, furthering its push into the new technology. Code Llama, which will be available for free, can write code based on human text prompts and can also be used for code completion and debugging, the social media giant said in a blogpost. Since the launch of OpenAI's ChatGPT late last year, enterprises and businesses have flocked to the nascent generative AI market for newer capabilities and refining business processes.
