

Indian Armed Forces Gets the First Woman Director General of Medical Service (ARMY)

NEW DELHI: Lt Gen Sadhna Saxena Nair has become the first woman to be appointed as the Director General Medical Services (Army). She has other firsts to her name: she was the first woman to hold the post of DG Hospital Services (Armed Forces) on promotion to the rank of Air Marshal.

Index of Eight Core Industries for June 2024

The combined Index of Eight Core Industries (ICI) increased by 4.0 per cent (provisional) in June, 2024 as compared to the Index in June, 2023. The production of Coal, Electricity, Natural Gas, Steel, Fertilizer sand Cement recorded positive growth in June 2024. The final growth rate of Index of Eight Core Industries for March 2024 stands at 6.3 per cent. The cumulative growth rate of ICI during April to June, 2024-25 was 5.7 per cent (provisional) as compared to the corresponding period of last year.

ADB Provides \$200 Million Loan for Solid Waste Management in India

Asian Development Bank and the Government of India recently signed a \$ 200 million (about Rs 1,700 crore) loan to improve solid waste management and sanitation in 100 cities across eight states in the country. The signatories to the loan agreement for the Swachh Bharat Mission 2.0 -Comprehensive Municipal Waste Management in Indian Cities Program were Juhi Mukherjee, Joint Secretary, Finance Ministry, and Mio Oka, Country Director for Asian Development Bank (ADB) - India Resident Mission, the Manila-based multilateral funding agency said in a statement on Tuesday.

Swapnil Kusale Secures Bronze Medal in 50m Rifle 3 Positions at Paris Olympics

Swapnil Kusale clinched the bronze medal in the men's 50m rifle 3 positions event at the Paris Olympics shooting competition on Thursday. India has won three medals at the 2024 Summer Games so far, all bronze, by shooters. Kusale's first-ever Olympic bronze in the 50m rifle 3 positions event took the country's overall medal tally to three at the ongoing Paris Games.



India Elected Vice-Chair of IPEF's Supply Chain Council

India has been elected as vice-chair of the supply chain council, one of the three bodies set up by the 14-member Indo-Pacific Economic Framework (IPEF) bloc, the commerce and industry ministry said Wednesday. The council was set up under the IPEF Supply Chain Resilience Agreement, which aims to help mitigate risks of economic disruptions from supply chain shocks, improve crisis coordination, and reduce the member countries' dependence on China.

Rapido Becomes Unicorn with Fresh \$120 Million Funding

Ride-hailing startup Rapido has raised a funding of \$120 million Capital in its latest Series E funding round led by its existing investor WestBridge, thus making it the latest company to join the coveted unicorn club. The investor poured in the fresh capital through three of its related entities – Setu AIF Trust, Konark Trust, and MMPL Trust, as per regulatory filings.



India's Fiscal Deficit Declines to 8.1% of Full-Year Estimate in Q1 FY25

A sharp reduction in capital expenditure (capex) during election months and record-high dividend from the Reserve Bank of India (RBI) led to a decrease in the central government's fiscal deficit to 8.41 per cent of the full-year target for the April-June quarter (Q1) of 2024-25 (FY25), according to the latest data released by the Controller General of Accounts (CGA) on Wednesday, along with the most recent FY25 Budget figures. However, CGA data, which uses Interim Budget figures, shows the Centre's fiscal deficit stood at 8.1 per cent in Q1FY25.

PM Marks 5 Years of Abrogation of Articles 370 and 35(A)

On the completion of five years since the abrogation of Articles 370 and 35(A), Prime Minister Narendra Modi on Monday said it was the start of a new era of progress and prosperity in Jammu and Kashmir and Ladakh. In a post on social media platform X (formerly Twitter), Prime Minister Narendra Modi said: "Today we mark 5 years since the Parliament of India decided to abrogate Articles 370 and 35(A), a watershed moment in our nation's history. RIL Jumps Up 2 Places in Fortune's Global 500 List for 2024

Oil-to-telecom-to-retail conglomerate Reliance Industries Ltd continues to be the highestranked Indian firm on the Fortune Global 500 list, jumping two places to be ranked at No.86 in the 2024 ranking. The firm was placed at No.88 in last year's ranking and has gained a whopping 69 places in the last three years - from being placed at No.155 in 2021 to being at No.86 in 2024. Releasing the 2024 list, Fortune on its website said Reliance has been on the 500 list for 21 years now. It had revenues of \$ 108.8 billion and a profit of \$ 8.4 billion last year.

Tata Group Unveils ₹27,000 Crore Semiconductor Facility in Assam

At the Tata Group's ₹27,000-crore greenfield semiconductor assembly and test facility in Assam, which is expected to be operationalised by next year, around 15 billion chips will be packaged annually for customers globally. For India's first indigenous facility for assembly and testing of semiconductor chips, the Bhoomi Pujan ceremony was performed on Saturday. The chips, which will be packaged at the Jagiroad facility in Assam, will power electric vehicles, healthcare devices, mobile phones, laptops, and other key products of leading global companies around the world.

Madras High Court Strikes Down Section 77-A of Registration Act as Unconstitutional

The Madras High Court on Friday declared as unconstitutional Section 77-A of the Registration Act, 1908, on the ground that it conferred excessive quasi-judicial power on the District Registrars to cancel documents related to any immovable property in the State if they were found to have been registered through fraud or on submission of forged revenue records.



Government Appoints Challa Sreenivasulu Setty as SBI Chairman

Challa Sreenivasulu Setty on Wednesday assumed charge as Chairman of the country's largest lender State Bank of India (SBI). He succeeds Dinesh Khara, who superannuated from services of the bank at the closing of business hours on Tuesday, SBI said in a regulatory filing. Prior to becoming chairman, Setty was the senior-most managing director of the bank. As per the convention, the chairman is appointed from a pool of serving managing directors of SBI. Usually, the senior-most managing director becomes chairman of the bank.

Govt Reverses Decision: Indexation Benefits Restored for LTCG Tax

In response to widespread criticism, the government has decided to roll back its controversial Budget proposal to remove indexation benefits on long-term capital gains (LTCG) tax from the sale of unlisted assets. Taxpayers now have the option to pay LTCG tax at a rate of 20 per cent with indexation benefit or at a new rate of 12.5 per cent without indexation benefit for properties acquired before July 23, 2024, as per amendments moved in the Finance Bill. Taxpayers are expected to choose the option resulting in the lower tax amount.

Deloitte India Predicts Economic Growth Between 7% and 7.2% in FY25

India's economy is expected to grow at 7-7.2 per cent in the current fiscal year driven by robust economic fundamentals and continuity in domestic policy reforms, Deloitte India said on Monday. The August update of Deloitte's India Economic Outlook said several initiatives in the Union Budget 2024-25 toward improving agriculture productivity, creating jobs for the youth, and in manufacturing and addressing the challenge of access to finance for micro, small, and medium enterprises (MSMEs).

RBI Hikes UPI Limit for Tax Payments to Rs 5 Lakh per Transaction

In a move aimed at boosting digital payments and facilitating larger transactions, the Reserve Bank of India (RBI) on Thursday increased the upper limit for tax payments through the Unified Payments Interface (UPI) to Rs 5 lakh per transaction from the current Rs 1 lakh limit. Previously capped at Rs 1 lakh, the enhanced limit is expected to provide convenience to taxpayers, especially for high-value transactions.

RBI Shortens Frequency of Credit Reporting to Fortnightly

The Reserve Bank of India (RBI) said on Thursday it is shortening the frequency of reporting by banks to Credit Information Companies (CICs) from once a month to once a fortnight. The move aims to improve timeliness and accuracy of credit information available to lenders. "The fortnightly reporting frequency would ensure that credit information reports provided by CICs reflect more recent information. This will be beneficial to both borrowers and lenders (CIs).

Pine Labs-owned Setu Launches UPISetu in Partnership with Axis Bank

Pine Labs-owned Setu, an application programming interface (API) infrastructure provider, introduced a Unified Payments Interface (UPI)-focused payments platform for businesses and developers in partnership with Axis Bank. The platform, named UPISetu, supports a wide range of UPI products, from basic QR code payments, UPI Autopay, equated monthly instalments (EMIs), and third-party validation service.

Odisha Launches India's First 'Rice ATM'

NEW DELHI: India's first round-the-clock grain ATM was inaugurated on Thursday at Mancheswar in Bhubaneswar, Odisha. The ATM, named Annapurti Grain ATM, was unveiled by Odisha's minister for Food Supplies and Consumer Welfare, Krushna Chandra Patra in the presence of Nozomi Hashimoto, deputy country director of the World Food Programme in India. This initiative aims to enhance nutritional security in the state by providing 24x7 access to rice and wheat.

Bharti Global to Acquire 24.5% Stake in BT Group

Bharti Enterprises, led by billionaire Sunil Bharti Mittal, will buy a 24.5% stake in British Telecom Group Plc, the UK's largest mobile and broadband services provider, the companies said in a statement Monday. Bharti Televentures UK Ltd, a wholly owned subsidiary of Bharti Enterprises's international investment arm Bharti Global, will buy the equity from telecom services provider Altice UK, which has a 24.5% stake in BT. Bharti Televentures will buy 9.99% of BT from Altice immediately, and the remaining 14.51% after receiving regulatory clearances.

L&T Finance Achieves NBFC-ICC Status from RBI

The subsidiaries involved in this consolidation include L&T Finance, L&T Infra Credit Ltd., and L&T Mutual Fund Trustee Ltd. The Reserve Bank of India (RBI) granted the new certificate of registration on August 2, 2024. This transition reflects L&T Finance Ltd.'s strategic move to streamline operations under the NBFC-ICC framework, which is not expected to impact the company's compliance with existing regulatory guidelines. In terms of financial performance, L&T Finance Ltd. reported a record net profit of ₹685 crore for the first quarter of FY25, marking a 29% year-on-year increase.

Government Reduces Crude Oil Tax, Eliminates Diesel and ATF Levies

The central government has reduced the windfall tax on petroleum crude to Rs 2,100 per metric tonne, down from Rs 4,600 per tonne, effective August 17. Earlier, on July 31, the windfall tax on crude was cut by 34.2 per cent to Rs 4,600 per tonne.



Net FDI Rises to \$6.9 Billion in Q1 FY25

Net foreign direct investment (FDI) during the April-June period of the current financial year was \$6.9 billion, compared to \$4.7 billion in the year-ago period, the latest data released by the Reserve Bank of India showed. The increase was due to an improvement in gross inward FDI, which grew by 26.4 per cent year-on-year (Y-o-Y) to \$22.5 billion during Q1 of 2024-25. Manufacturing, financial services, communication services, computer services, and electricity and other energy sectors accounted for about 80 per cent of the gross FDI inflows.

Amul, a company with over seven decades of history, has been recognised as the world's strongest food brand in Brand Finance's Global Food & Drinks Report 2024. Amul's brand value saw an 11 per cent increase from 2023, reaching \$3.3 billion in the latest ranking. The brand value, however, should not be confused with turnover.

NCLT Approves Slice-North East Small Finance Bank Merger

Consumer payments and lending company Slice on Monday said it has received approval from the National Company Law Tribunal (NCLT) for its merger with North East Small Finance Bank (NESFB). The NCLT Guwahati bench has sanctioned the scheme of arrangement and amalgamation involving Garagepreneurs Internet Pvt Ltd, Quadrillion Finance Pvt Ltd, Intergalactory Foundry Pvt Ltd, RGVN (North East) Microfinance Ltd, and North East Small Finance Bank, the company said in a statement.

Zomato Acquires Paytm's Entertainment Ticketing Business

Food delivery giant Zomato on Wednesday completed the acquisition of fintech major Paytm's entertainment ticketing business, Paytm Insider, both the companies said in regulatory filings.



Neeraj Chopra Finishes Second in Lausanne Diamond League

India's ace javelin thrower Neeraj Chopra finished 2nd at the Lausanne Diamond League event in Switzerland. He achieved his season-best throw of 89.49 meters during the competition. As per Olympics.com, Chopra missed the 90m mark by just 51cm. In the competition, Anderson Peters of Grenada claimed the first place with a remarkable throw of 90.61 meters, setting a new record. Germany's Julian Weber took third place with a throw of 87.08 meters. Peters had previously won bronze at the Paris Olympics 2024.

Nelson Mandela Legacy Sites Inscribed as UNESCO World Heritage

Johannesburg: President Cyril Ramaphosa has welcomed the listing of several iconic sites in South Africa linked to the late President Nelson Mandela as UNESCO World Heritage Sites. Listed generically as 'The Human Rights, Liberation and Reconciliation: Nelson Mandela Legacy Sites' by the United Nations Educational, Scientific and Cultural Organisation (UNESCO), these include 14 human rights and liberation struggle sites linked to Mandela, who served 27 years as a political prisoner before becoming South Africa's first democratically elected President after decades of white minority apartheid rule.

President Murmu's Six-Day Visit to Fiji, New Zealand, and Timor-Leste

President Droupadi Murmu on Sunday left for a six-day visit to Fiji, New Zealand and Timor-Leste. China to Launch Satellite Constellation to Rival Musk's Starlink

A Chinese state-owned enterprise on Tuesday successfully placed 18 satellites into orbit, state broadcaster CCTV reported, as China seeks to create its own version of U.S. firm SpaceX's Starlink network. The launch of the low Earth orbit (LEO) satellites by Shanghai Spacecom Satellite Technology (SSST) took place at Taiyuan Satellite Launch Centre in the northern Shanxi province. The satellites were carried aboard a Long March 6 rocket and represent the first batch in SSST's "Thousand Sails Constellation" plan, CCTV reported.

Vinesh Phogat Disqualified in Paris Olympic 2024

In a heartbreaking turn of events, Vinesh Phogat has been disqualified from the Paris 2024 Olympics wrestling competition for being overweight in the women's 50kg category on the morning of her gold medal bout on Wednesday. At Paris 2024, each weight category is organised over two competition days. The medical control and weigh-in for each category takes place in the morning of the first competition day. On the second competition day, wrestlers who have qualified for the finals and repechage are weighed in again.

DBS Appoints Tan Su Shan as First Female CEO

DBS Group said on Wednesday that Tan Su Shan, the firm's head of institutional banking, will succeed Chief Executive Piyush Gupta upon his retirement in March, making her the first female CEO of Singapore's biggest bank. Tan, who joined the bank in 2010, will serve as the deputy CEO till then, DBS said in a statement. CEO Piyush Gupta retires on 28 March 2025, when the bank hosts its next annual general meeting.

Neeraj Chopra Clinches Silver in Javelin at Paris 2024 Olympics

Neeraj Chopra of India secured silver in the men's javelin throw at the Paris 2024 Olympics. Pakistan's Arshad Nadeem won gold with an Olympic record throw of 92.97m and Anderson Peters of Grenada earned bronze.

This achievement follows NIPL's collaboration with Fonepay, Nepal's largest payment network, to introduce cross-border UPI P2M acceptance in March 2024. The milestone reflects growing digital payment connectivity between India and Nepal.


"King Khan" Receives Lifetime Award at Locarno Film Festival

China Tests Largest Cargo Drone as Low-Altitude Economy Expands

China flew its biggest-yet unmanned cargo aircraft designed for civilian use, as the world's top drone-making nation steps up test flights of autonomous aerial vehicles (UAVs) that could ultimately ferry everything from takeouts to people. Packing a payload capacity of 2 metric tons, the twin-engine aircraft took off on Sunday on an inaugural flight, state media said, citing developer Sichuan Tengden Sci-tech Innovation Co., for a trip of about 20 minutes in southwestern Sichuan province.

China Approves \$31 Billion for 11 New Nuclear Reactors Across Five Sites

China approved 11 nuclear reactors across five sites on Monday, a record amount of permits as the government leans even more heavily on atomic energy to support its push to cut emissions. The State Council greenlighted the new reactors in sites spread across Jiangsu, Shandong, Guangdong, Zhejiang and Guangxi, state-run China Energy News reported. The total investment for all 11 units will be at least 220 billion yuan (\$31 billion) with construction taking about five years, according to financial publication Jiemian.

SpaceX's Polaris Dawn Mission: The First Private Spacewalk

SpaceX has postponed its attempt to launch an expedition featuring an all-civilian crew that is aiming to carry out the first-ever spacewalk by private citizens. The mission, known as Polaris Dawn, had been scheduled to take off from Nasa's space centre in Florida early on Wednesday morning.



Typhoon Shanshan Makes Landfall on Japan's Kyushu Island

Japan's strongest typhoon of the year has made landfall in the country's south-west, bringing torrential rain and winds of up to 252 km/h (157 mph), strong enough to destroy homes. The meteorological agency said Typhoon Shanshan, referred to in Japan as Typhoon No 10, made landfall on the island of Kyushu at around 8am. The power company said 254,610 houses were already without electricity.
