

India Secures Presidency of IIAS for 2025–2028 Term

New Delhi: In a marker of India's internal governance reforms and the country's rising stature in global governance, the country has been elected to lead the prestigious International Institute of Administrative Sciences (IIAS) for the 2025-2028 term. This is the first time in the nearly 100-year history of the Belgium-based institute that India will hold the presidential post. This marks a significant recognition of India's administrative evolution and reformoriented governance, sources said.

Nomura Forecasts India's GDP to Slow to 6.2% in FY26

India's real GDP growth in FY26 will slide further to 6.2 per cent in FY26 from 6.5 per cent in FY25, a Japanese brokerage said on Monday. In a research report, Nomura said there is a "divergence" between the growth in GST collections and across other high-frequency growth indicators like auto sales and bank credit growth. As per the official data released last week, the real GDP growth came down to 6.5 per cent in FY25 from 9.2 per cent in FY24.

PM Modi Inaugurates World's Highest Railway Arch Bridge in Jammu & Kashmir

Indian Prime Minister Narendra Modi has inaugurated the world's highest single- arch railway bridge in Indian-administered Kashmir. The term "single-arch bridge" typically refers to a bridge with a single, continuous arch spanning between two supports.



Aadhaar Authentications Cross 211 Crore in May 2025, Driving India's Digital Growth

NEW DELHI: The Unique Identification Authority of India (UIDAI) recorded over 211 crore Aadhaar authentication transactions in May 2025, reflecting the growing reliance on India's digital identity infrastructure for welfare delivery and service access. This marks an increase over both April 2025 and the 201.76 crore transactions recorded in May last year. With this, the cumulative number of Aadhaar authentications since its inception has crossed 15,223 crore.

"It would prove to be a milestone in the path to freeing administration from the influence of foreign languages," Shah said as he announced the formation of Bharatiya Bhasha Anubhag.

RBI Raises Gold Loan LTV Ratio to 85% for Loans Below ₹2.5 Lakh

Providing relief to small borrowers, the Reserve Bank of India (RBI) has increased the loan-tovalue (LTV) ratio for gold-backed loans up to ₹5 lakh, while the LTV for loans below ₹2.5 lakh has been set at 85 per cent, and those between ₹2.5 lakh and ₹5 lakh at 80 per cent. However, all loans above ₹5 lakh will have an LTV of 75 per cent, the central bank specified in its final guidelines for lending against gold and silver collateral.

Starlink Gets Green Light to Launch Satellite Internet in India

Big news for internet in India! Elon Musk's Starlink, which offers super-fast internet from satellites, just got a major approval from the Indian government on June 6th, reports Reuters. This means Starlink can now get ready to launch its service in India. Starlink is already available in over 100 countries and promises to bring high-speed internet to places where regular internet doesn't work well. It's like saying goodbye to areas with no internet!.

Muhammad Waseem and Chloe Tryon Named ICC Players of the Month for May 2025

The United Arab Emirates batter Muhammad Waseem and South Africa all-rounder Chloe Tryon have been named as the ICC Men's and Women's Players of the Month for May 2025. Waseem wins the award for the second time after a string of good performances in the ICC Men's Cricket World Cup League 2 and a home T2OI series against Bangladesh. The 31-year-old scored 169 runs in five ODIs batting in the middle order and was the Player of the Series in the series against Bangladesh in Sharjah which his side won 2-1.

Kerala's Public Health Lab Develops Molecular Test Kits for Deadly Amoeba

T'puram: In a significant development, the state confirmed its first case of amoebic meningoencephalitis through the newly established molecular lab in the state. Health Minister Veena George announced that the diagnosis was made as part of a dedicated effort to detect amoebic brain fever, a rare but often fatal condition. State public health lab (SPHL) earlier set up a PCR lab capable of detecting five types of amoebae known to cause brain fever in humans — Naegleria fowleri, Acanthamoeba sp., Vermamoeba vermiformis, Balamuthia <u>mandrillaris, and Paravahlkampfia francinae.</u>

PM Modi to Attend G-7 Summit in Canada, Signaling Thaw in Bilateral Ties

Mark Carney has invited his Indian counterpart Narendra Modi to the upcoming G7 summit in Alberta, marking a shift in Canada-India relations that had soured in recent years. The two spoke over the phone on Friday, during which the Canadian prime minister extended the invite to Modi and agreed to stay in contact, according to a readout released by Carney's office. Modi confirmed the invite and thanked Carney in a post on X, adding that he looked forward to meeting him at the summit in mid-June.

By 2030, Mumbai, Delhi & 6 Other Cities to See Twofold Rise in Heatwaves

Delhi is one of eight Indian cities projected to experience a two-fold increase in the number of heatwave days by 2030, according to a latest research report. Mumbai, Chennai, Surat, Thane, Hyderabad, Patna, and Bhubaneswar are the seven other cities that are at a similar risk.



SEBI Opens Settlement Window for Stock Brokers in Algo Trading Violation Cases

The Securities and Exchange Board of India (Sebi) on Monday announced a settlement scheme for stock brokers associated with certain algorithmic trading (algo) platforms that were found to be in violation of regulatory norms. The matter pertains to regulatory scrutiny faced by over 100 brokers for their association with algo platforms that allegedly promised guaranteed returns. It was alleged that the brokers had allowed the application programming interfaces (APIs) of algo provider TradeTron — which claimed to offer assured returns — to be used by their clients.

Aadhaar OTP Must for Tatkal Bookings from July 15: Railways Issues New Rules

Beginning July 1, individuals looking to book Tatkal train tickets through the IRCTC website must have their Aadhaar linked to their IRCTC profile. Indian Railways has advised travelers to connect their Aadhaar numbers with their IRCTC accounts to prevent any disruptions. Meanwhile, the Centre for Railway Information Systems (CRIS) and IRCTC have been directed to carry out the necessary system updates and notify all Zonal Railways and concerned departments about the changes. The Railway Ministry stated that the changes are aimed at "promoting fair and transparent access to Tatkal tickets while protecting the rights of genuine passengers."

Chief Minister Devendra Fadnavis has virtually launched a landmark project focused on marine conservation and tourism, setting the stage for a transformative initiative.

IREDA Raises ₹2,005.90 Crore via QIP to Power Renewable Energy Push

NEW DELHI: Indian Renewable Energy Development Agency Ltd (IREDA) has successfully raised Rs 2,005.90 crore through a Qualified Institutions Placement (QIP), said a statement from Ministry of New and Renewable Energy on Wednesday. The capital was mobilised by issuing 12.15 crore equity shares at a price of Rs 165.14 per share, which includes a premium of Rs 155.14 per share over the face value of Rs 10. The issue price of Rs 165.14 reflects a discount of 5.00% to the floor price of Rs 173.83 per equity share.

RBI Eases KYC Norms: Allows BCs and Video Uploads

Reserve Bank of India (RBI) has directed banks and NBFCs to allow all transactions from so called low risk customers even if their KYC is pending. These customers have time till June 30, 2026 to update their KYC but transactions on their accounts will not be halted, RBI said. Banks and NBFCs have to give at least three advance notices and at least one by a letter at appropriate intervals to customers through available communication options/ channels for complying with the requirement of periodic updation of KYC.

Scapia & Federal Bank Launch Dual-Network RuPay-Visa Credit Card

Travel fintech firm Scapia has launched a dual credit card in partnership with private sector lender Federal Bank, based on a single credit line for customers. Scapia users can see a unified credit card statement, and a single bill is generated at the end of the billing cycle. The company targets young millennials and Gen Z customers who are looking for travel offers and rewards. The cobranded card issued and managed by Federal Bank has a Visa version that is expected to be used internationally.

Apna.co Launches AI Job Prep Tool to Transform Interview Preparation

Apna.co, a jobs platform, has launched AI Job Prep — a new AI-powered interview preparation tool designed to address the preparation gap in the country's job market. "Over 7.6 lakh AI interviews have been completed on Apna's platform, across over 900 cities and towns, logging more than 39 lakh minutes of interviews — signalling a growing demand for smarter, tech-enabled ways of interview preparation," the firm said.

India's 16th Census Announced for 2027

The much-delayed 16th Census exercise, along with caste enumeration, will be carried out with a reference date of October 1, 2026 in snow-bound areas like Ladakh, and March 1, 2027 in the rest of the country, the Ministry of Home Affairs (MHA) announced on Wednesday. According to officials, the process will begin with the issuance of a notification, which is tentatively scheduled to be published in the official gazette on June 16, 2025, under Section 3 of the Census Act, 1948. The final phase of enumeration will begin in February 2027 and conclude on March 1, 2027, which will serve as the national reference date.

Meta Appoints Arun Srinivas as India Head to Lead Business Expansion

Meta has announced the appointment of Arun Srinivas as the new managing director and head for India. This development comes on the heels of Sandhya Devanathan assuming an expanded role, where she now leads both India and South East Asia. In this expanded capacity, Srinivas will be responsible for aligning Meta's business, innovation, and revenue priorities to better serve its partners and clients in India. TCS Joins Hands with CEB to Streamline Financial Operations

Tata Consultancy Services (TCS) has partnered with the Council of Europe Development Bank (CEB) to modernise and automate the bank's reconciliation processes. TCS will implement its TCS BaNCS for reconciliations platform, leveraging artificial intelligence and automation to streamline complex transactions, improve transparency, and reduce manual effort, according to a regulatory filing.



Maruti Suzuki Partners with Equitas Bank to Boost Retail Car Financing

Leading car maker Maruti Suzuki India Ltd has partnered with private sector Equitas Small Finance Bank to offer vehicle financing options to its customers, a company official said on Friday. A memorandum of understanding between the two entities was signed with an aim to provide retail financing options for new cars, used cars and commercial vehicles. "The collaboration is set to enhance the accessibility and affordability of Maruti Suzuki vehicles for a broader range of customers," a company statement here said.

Maruti Suzuki Opens India's Largest In-Plant Railway Siding at Manesar

The Gati Shakti Multi-Modal Cargo Terminal, with a loading capacity of 450,000 vehicles per annum, is a key infrastructure development that significantly enhances the logistics efficiency of automobile transportation.

Govt Launches ₹3000 FASTag Annual Pass for Private Vehicles

Soon, road users driving through national highways will be able to make 200 trips by paying only ₹3,000 as toll fee over a period of 12 months, according to an announcement by Minister for Road Transport and Highways Nitin Gadkari. He said a FASTag-based annual pass would be introduced to address concerns over rising toll fees across the country.



Bihar Pioneers India's First Mobile-Based e-Voting System

Bihar State Election Commissioner Deepak Prasad on Friday (June 27, 2025) had shared the information to media that for the first time, voters in the Bihar municipal elections would be able to cast vote through mobile for six councils in Patna, Rohtas and East Champaran district on Saturday (June 28, 2025). The facilities are available for those people who are unable to go to polling booths to cast their votes. Senior citizens, disabled people and pregnant women can avail this option.

RBI Hikes Agency Commission for Banks on Government Transactions

The Reserve Bank of India (RBI) has increased the agency commission for banks conducting government business such as revenue receipts and payments, pension payments, among others. This is possibly aimed at encouraging the agency banks to bring in more efficiency in putting through government-related transactions. The revised agency commission rate for banks putting through revenue receipt and payment transactions on behalf of the Central/State Governments in electronic (e-) mode has been upped to ₹12 per transactions against ₹9.

Hyderabad Becomes Google's Cybersecurity Hub with GSEC Launch

HYDERABAD: Tech giant Google unveiled its first safety engineering centre (GSEC) in the Asia Pacific (APAC) region and its fourth globally after Munich, Dublin, and Malaga (Spain), in Hyderabad on Wednesday. GSEC India is housed within what is Google's largest base outside the US and was also its first port of call in India in 2004. An official statement said GSEC India will not only address the rapidly evolving threat landscape of India, which faces projected cybercrime losses of up to Rs 20,000 crore by 2025.

Starlink Gets Licence Nod in India as Airtel and Jio Join Hands with Space

The wait for Starlink's India entry is over. In a crucial move for the Indian telecom sector, the Indian government has finally granted the operating permission to Elon Musk's SpaceX-owned Starlink satellite internet service. In an official post from Jyotiraditya M. Scindia, the Union Minister for Communications and Development of North Eastern Region, it is confirmed that the operating license has been granted to Starlink, thus enabling SpaceX's official entry into India. Union Communications Minister Jyotiraditya Scindia shared that he had a "constructive discussion" with Gwynne Shotwell, the President and COO of SpaceX, which owns Starlink.

TVS iQube Debuts in Indonesia: A Milestone in Global EV Expansion

TVS Motor Company on Tuesday (June 17, 2025) announced its foray into the Indonesian electric two-wheeler market with its all-electric scooter iQube. The company's arm PT TVS Motor has opened bookings for iQube in Indonesia at an introductory price of Indonesian Rupiah (IDR) 29.9 million (around ₹1.6 lakh), TVS Motor Company said in a statement. "The main goal of this is simplifying real-time verification of PAN details, bank account status, and account holder identities straight from banks' Core Banking Systems (CBS)," the NPCI circular stated. The new facility was announced in a circular dated June 17, 2025.

S&P Global Ratings Boosts India's GDP Forecast to 6.5% Amid Global Economic Uncertainties

S&P Global Ratings on Tuesday raised India's GDP growth forecast for the current fiscal year (FY26) to 6.5 per cent, citing expectations of a normal monsoon, lower crude oil prices, and monetary policy easing. This comes as a positive shift after S&P had trimmed its forecast just last month due to global uncertainties. In its latest Asia-Pacific Economic Outlook report, S&P emphasised that domestic demand resilience is playing a key role in supporting India's economic momentum.

Adani Group Pioneers India's Clean Energy Future with First Off-Grid Green Hydrogen Plant

Adani Group has commissioned India's first off-grid 5 megawatt green hydrogen pilot plant in Kutch, Gujarat, the conglomerate said in a statement on Monday (June 23, 2025). An off-grid green hydrogen plant is a facility that produces hydrogen using electrolysis powered by renewable energy sources, such as solar or wind, and is not connected to the main electrical grid.

Tata Group Becomes India's First \$30-Billion Brand: Brand Finance 2025

Tata Group (brand value up 10 per cent to \$31.6 billion) has once again secured its position as India's most valuable brand, becoming the first Indian brand to cross the \$30 billion threshold, according to a report by Brand Finance. "This historic milestone underscores India's expanding economic clout and the Tata Group's multi-sector dominance, with strategic investments in electronics, EVs, semiconductors, AI and renewables," the report stated.

Four years after the launch of nano urea in the country, Indian Farmers Fertiliser Cooperative IFFCO is setting up its first plant abroad for manufacturing nano-soil nutrients in Brazil.

JioBlackRock Broking Gets SEBI Nod to Launch Brokerage Operations

Jio BlackRock Broking Pvt Ltd, a wholly owned subsidiary of Jio BlackRock Investment Advisers Pvt Ltd, has received regulatory approval from the Securities and Exchange Board of India (Sebi) to commence operations as a brokerage firm.JioBlackRock Broking aims to bring affordable, transparent, and technology-driven execution capabilities for investors, the company said in a statement.

Adani Green Becomes First Indian Firm to Cross 15 GW Renewable Energy Milestone

Adani Group's renewable arm, Adani Green Energy (AGEL), has become the first Indian company in its field to surpass 15,000 megawatts (MW) or 15 gigawatts (GW) of installed operational capacity. In an exchange filing on Monday, the company announced that its total capacity stood at 15,539.9 MW as of June 2025.

Bangladesh Unveils New Banknotes, Drops Mujibur Rahman's Portrait
