

Rohit Tiwari's wife charged with his murder, arrested

Apoorva Shukla, wife of Rohit Shekhar Tiwari, has confessed to the crime of killing her husband, the Delhi Police said on Wednesday, after her arrest from her Defence Colony residence Rohit Shekhar was declared brought dead at a city hospital on April 16. Additional Commissioner of Police Rajiv Ranjan said Ms. Apoorva had confessed to committing the crime. The case, so far, was being viewed as a case of sudden provocation as opposed to a preplanned murder.

Akshay Kumar to engage in a 'completely non political' conversation with PM Narendra Modi

A day after Akshay Kumar said he would be getting into an "unknown and uncharted territory" with something he had not done before, the Bollywood actor Tuesday said he will have a "candid and completely non political" chat with Prime Minister Narendra Modi on Wednesday. The 51-year-old star took to Twitter to announce that his conversation with the prime minister will be a "breather" in election time.

Crypto currency is 'ponzi scheme', should be banned in India: Govt official

Crypto currency is a "ponzi scheme" and should be banned to protect the interest of investors, a government official said Friday. Amid continuing debates about crypto currencies such as Bitcoins, the Investor Education and Protection Fund (IEPF) Authority, which comes under the corporate affairs ministry, is in favour of banning trade in such currencies. Crypto currencies are based on blockchain technology and there are concerns about its viability in the long-term and risk to investors, especially considering steep fluctuations in the prices.

Biosimilars to help Biocon cross \$1 billion revenue in FY20

BENGALURU: Searing growth in its biosimilar business is expected to help see Biocon cross \$1 billion in revenue this fiscal. Biosimilars, or biologics, are biological drugs that are developed to be highly similar and clinically equivalent to an existing biological drug, and they can be developed once the original drug's patent expires. Biological drugs are made from complex molecules manufactured using living microorganisms, plants, or animal cells. Biocon's biosimilars, the first of which was insulin Glargine and which was launched in 2016 in Japan, contributed Rs 1,517 crore in the recently concluded fiscal, from just Rs 342 crore three years back, a CAGR of 45%.

Sachin Bansal marks fifth debt deal in two months

MUMBAI: Flipkart co-founder Sachin Bansal, who made a personal fortune of close to \$1 billion after selling the online retailer to Walmart last year, has found a new calling in debt deals. On Monday, Bansal invested ₹20 crore in debt in online grocery and milk delivery startup Milkbasket, the latest in a series of debt deals that he has entered into since exiting Flipkart. The small size of the deal notwithstanding, the transaction underlines a distinct pattern in Bansal's investments.

Only one hurdle remains in Jio's path to India domination

The first decisive pecking order reset forced by Mukesh Ambani on Indian telecom is here. As per recently released data, Jio has now left AirteINSE -2.01 % behind in subscriber base to become as India's second-biggest telecom company. The number of Jio customers now stands at 30.6 crore — behind only Vodafone-Idea which has 38.7 crore. It means with 28.4 crore customers, Airtel now slips to third place.

Lok Sabha polls 2019: PM Modi files nomination from Varanasi

Prime Minister Narendra Modi filed his nomination papers for the Varanasi Lok Sabha seat on Friday, accompanied by a galaxy of top BJP and NDA leaders in what was a massive show of strength for the country's ruling alliance. Bihar Chief Minister and JD-U chief Nitish Kumar, Union minister and LJP chief Ram Vilas Paswan, Shiv Sena supremo Uddhav Thackeray and Shiromani Akali Dal patron Parkash Singh Badal were with Modi.

CBI issues look-out notice against Bhushan steel boss, wife in bank fraud case

The CBI on Wednesday issued a Look-out Circular against Bhushan Steel CMD Sanjay Singhal, vice chairman Aarti Singhal in a Rs 2,348 crore bank fraud case. On April 6, the CBI had in a statement said that it had filed a case under the charges of corruption and criminal conspiracy against the company - Bhushan Steel, it's CMD Sanjay Singhal, Vice Chairman Aarti Singhal, director Ravi Prakash Goyal, full time director Ram Naresh Yadav, three other senior functionaries of the company and unknown government servants.

Weather forecast today, Cyclone Fani highlights: Cyclonic storm to turn 'severe' tonight, Kerala braces for heavy rains

72 Lok Sabha seats in 9 states go to polls in 4th phase on Monday

New Delhi: Polling will be held on Monday for the fourth phase of Lok Sabha election in 72 parliamentary constituencies spread across nine states. The stakes are high for the ruling BJP and its allies as it had swept 56 of these seats in 2014, leaving just two for the Congress and the rest for other opposition parties such as the Trinamool Congress (six) and the Biju Janata Dal (six).

Letters prove Netaji was Gumnami Baba: Book

A leading American handwriting expert has concluded that Net aji Subhas Chandra Bose lived in India for several decades after Independence, under the identity of a reclusive ascetic Gumnami Baba, claims a new book. The expert, Carl Baggett, reached his conclusion after studying letters written by both Bose and Gumnami Baba. Baggett is an authority on document examination with over 40 years of experience and has completed over 5,000 cases. Certified by the American Bureau of Document Examiners.

Conspiracy probe after harassment investigation against CJI Ranjan Gogoi

New Delhi: Former Supreme Court judge AK Patnaik, who is tasked with probing an alleged conspiracy to frame Chief Justice of India Ranjan Gogoi in a sexual harassment case, will start his inquiry only after an in-house inquiry against Gogoi is completed. "I will start only after the in-house committee completes its probe as there is no time limit fixed by the Supreme Court to submit the report of my inquiry into the affidavits sent to me by the court," Justice Patnaik told ET on Friday.

Yes Bank reports its first ever quarterly loss of ₹1507 crore

MUMBAI: Private sector lender Yes Bank Ltd on Friday reported its first-ever quarterly loss at ₹1,506.64 crore on the back of higher provisions. The bank would have reported a steeper loss if not for a tax write-back of ₹832 crore in the March quarter. Meanwhile, the bank's board approved the appointment of Ravinder Kumar Khanna and Shagun Kapur Gogia as additional directors (non-executive, non-independent) with immediate effect.

Tatas' election expenditure rises more than 20 times since 2014

The Tata group, through its electoral trust, is learnt to have contributed Rs 500-600 crore towards the 2019 Lok Sabha (LS) elections, pushing up its poll expenditure by more than 20 times since 2014. In the financial year 2014-15, it disbursed Rs 25.11 crore to political parties, according to official filings made by Progressive Electoral Trust, the Tata group's election funding vehicle. For the ongoing elections, it has made contributions to all national parties, with the biggest chunk going to the Bharatiya Janata Party (BJP).

Chinese smartphone brands increase India market share

NEW DELHI: Chinese phone makers are clearly making their presence felt in the Indian smartphone market. India's overall smartphone shipments grew just 4% annually but the market share of Chinese brands in the Indian smartphone market touched 66% in the first quarter of this calendar year, according to a report released by Counterpoint's Market Monitor service today. Xiaomi remained the smartphone market leader in Q1 2019 with a 29% share, though its shipments declined by 2% YoY.

Rajan said to be in the running for post of Bank of England Guv

London: The UK government on Wednesday formally launched its hunt for a new Bank of England Governor, a post for which former Reserve Bank of India (RBI) governor Raghuram Rajan has been widely named as among the contenders. UK Chancellor Philip Hammond told the House of Commons Treasury Committee that it was important the person who took over from current Governor Mark Carney at the end of his term in January 2020.

Maruti to pull the plug on diesel cars in April 2020

Car buyers eyeing a diesel-powered vehicle from the Maruti Suzuki stable will have less than a year to make their choice as the company plans to stop manufacturing such vehicles starting next financial year. Maruti Suzuki, which is the largest car maker in the country, on Thursday, announced plans to discontinue selling all diesel cars in the country from April 1, 2020, citing uncertainty over demand for such vehicles due to "significant" increase in price once the new BS VI emission norms kick in.

Farmers in a fizz as PepsiCo files suit over potato IPR violation

A full-blown fight has broken out potato farmers in Gujarat and multinational food giant PepsiCo India Holdings Pvt Ltd (PIH). The issue: alleged infringement of intellectual property rights (IPR) of a plant variety registered under the Protection of Plant Varieties and Farmers' Rights (PPV&FR) Act, 2001. A group of farmer organisations and civil society representatives upped the ante against PepsiCo India after the MNC filed lawsuits against four potato growers.

Naspers checks out of MakeMyTrip with Ctrip share swap deal

BENGALURU: China's largest online travel agency now owns nearly half of India's largest travel e-portal, MakeMyTrip, after a share-swap deal with South African internet giant Naspers Ltd. The swap will see the stake of China's Ctrip.com International Ltd in Nasdaq-listed MakeMyTrip Pvt. Ltd increase to around 49%, along with 4% of total voting rights, while Naspers will end up owning 5.6% of the Chinese company's shares.

Ex-Army Chief Dalbir Singh Suhag named Indian High Commissioner to Seychelles

Former Indian Army Chief General Dalbir Singh Suhag has been appointed as the next High Commissioner of India to the Republic of Seychelles, the Ministry of External Affairs said on Thursday. "He is expected to take up the assignment shortly," a statement from the MEA read. The development puts to rest speculations about the former Army Chief joining politics. Dalbir Singh Suhag was the Army Chief when the Special Forces commandoes of the Indian Army conducted surgical strikes at terrorist launch pads inside Pakistan Occupied Jammu and Kashmir (PoK).

World's biggest gets bigger, TOI readership soars 17%: IRS

The world's biggest English language newspaper just got bigger. The Times of India recorded a staggering growth of 17% on an already massive base – adding 2.2 million, or 17%, in total readership to 15.2 million in the first quarter of 2019, from 13 million in the same period in 2017. There are seven English general interest broadsheet dailies including TOI, in the top 10 (of the remaining three, two are tabloids and one is a business paper), according to the latest findings of the Indian Readership Survey (IRS).

Supreme Court declines to lift stay on release of PM Modi biopic

New Delhi: Saying it "won't interfere" with an Election Commission (EC) order banning a biopic on Prime Minister Narendra Modi until 19 May, the Supreme Court on Friday refused to lift the stay on the release of the movie starring Vivek Oberoi. A bench headed by chief justice Ranjan Gogoi said it was not inclined to entertain the application filed by producers of the biopic challenging the EC's order.

Bajrang Punia to be first Indian wrestler at New York fight Night

NEW DELHI: Indian wrestling's poster boy Bajrang Punia will soon walk the famed hallways of the iconic Madison Square Garden in New York, US. Bajrang is the first Indian to be invited by USA Wrestling, the national governing body for the sport in the US, to participate in the "Grapple at the Garden - Beat the Streets" fight night, scheduled on May 6. Bajrang will take on two-time US national champion Yianni Diakomihalis in the 65kg category.

Supreme Court gives RBI 'last chance' to alter disclosure policy

The Supreme Court on Friday gave the Reserve Bank of India (RBI) "a last opportunity" to withdraw a November 2016 Disclosure Policy to the extent to which it stonewalls revelation of every other kind of information under the Right to Information Act, including the list of wilful defaulters and annual inspection reports. A Bench of Justices L. Nageswara Rao and M.R. Shah found the policy of the central bank to be directly contrary to the court's judgment.

India set to launch second mission to the moon Chandrayan-2 in July, says ISRO

NEW DELHI: After being deferred several times in last one year, India's second mission to the moon - Chandrayaan 2 is now all set to be launched in July. The Indian Space Research Organization (ISRO) which had initially planned to launch the mission last year in April, confirmed that the all the modules for the mission would be ready in the next two months. "All the modules are getting ready for the Chandrayaan-2 launch during the window of July 9 to July 16.

Mysterious footprints found in the Himalayas. Army says it could be of mythical snowman

The Indian Army claimed to have found the footprints of a mythical beast called 'Yeti' in the Himalayas. As per the Twitter handle of the Army, an expedition team has found mysterious footprints measuring 32x15 inches close to Makalu Base Camp on 09 April 2019. "This elusive snowmanNSE -2.44 % has only been sighted at Makalu-Barun National Park in the past," the tweet further added. The pictures, however, only show the print of only one foot.

BlackBerry Messenger shuts down this month, here's what you need to know

One of the first instant messaging applications, BlackBerry Messenger (BBM), is going to shut down on May 31. On April 18, Emtek, the company that has run BBM since 2016, announced the closure of the consumer version of the app. The company cited dwindling number of users as the reason for the closure. However, BlackBerry followed up that announcement by offering the enterprise version (BBMe) of the software to consumers.

Polling over in 424 seats, spotlight on eastern UP

NEW DELHI: Elections 2019 have begun to wind down with polling completed in 424 of the 543 Lok Sabha seats after Monday's fifth phase, which saw voting in 51 seats across seven states. As many as 80% of these seats are categorised as rural. The voter turnout, at 62.56% until 6 pm, was slightly higher than that recorded in 2014. Polling in Bihar and Rajasthan went up by 2 percentage points.

Sebi finds NSE guilty of lapses in algo trade case

MUMBAI: The markets regulator on Tuesday cracked the whip on National Stock Exchange of India Ltd (NSE), directing it to deposit nearly ₹1,000 crore in an investor fund and barring it from accessing capital markets for six months, besides clawing back a chunk of salaries from its two former CEOs, for lapses in its algorithmic trading systems and co-location services. BJP eyes election boost from Masood Azhar's ban by UN

The Anil Ambani group on Sunday took Congress President Rahul Gandhi head on by calling the latter's allegations of crony capitalism against its chairman as "calumny, disinformation, distortion, and malicious lies." In recent election-eve media interactions and rallies, Rahul has singled out Anil Ambani several times for winning the Rafale defence contract from the Narendra Modi government, alleging favouritism and corruption. The Marvel superhero film has made Rs 244 crore (nett) in six days, and Rs 290 crore gross. Infinity War had concluded its run with around Rs 230 crore nett. Trade analyst Taran Adarsh called the performance an 'eye-opener' and said that the film is competing with the biggest Hindi films.

Tej Bahadur's papers rejected; SP retains Shalini Yadav

Varanasi: The nomination papers of dismissed BSF jawan Tej Bahadur Yadav has been rejected by the returning officer for Varanasi Lok Sabha constituency following his failure to submit a certificate that 'he was not sacked for either corruption or disloyalty'. After Yadav's paper was rejected, 31 candidates were in the fray for the seat, including Prime Minister Narendra Modi. "Shri Tej Bahadur has stated that he has been dismissed from government service on April 19, 2017.

Patanjali's ₹4,325 crore bid for Ruchi Soya gets lenders nod

NEW DELHI: In its first major acquisition, Yoga guru Baba Ramdev-led Patanjali Ayurved walked away with debt-ridden edible oil firm Ruchi Soya with a bid of ₹4,325 crore, sources said. Patanjali acquired Ruchi Soya Industries in an insolvency auction started by lenders to recover over ₹9,300 crore loans. Homegrown FMCG major almost got a walk over after rival Adani Wilmar decided to pull out from the race despite being selected the highest bidder few months back.

Although neither party is willing to put a figure to the deal, the industry estimate is that the plot went under the hammer for close to Rs 200 crore. The plot is located on the Sion-Panvel highway, an arterial road that connects the southern tip of the city with many townships of Navi Mumbai.

Father, brother killed in accident on exam eve, Ghaziabad girl scores 92.4% in class 10

On the eve of class 10 board exams, while other students were busy with last-minute revisions and hectic preparations, Tiya Singh was coping with her world crumbling around her. For the 15-year-old, it was sleepless night, one that was fraught with grief and trauma. Only hours before, she had lost her father and her 11-year-old brother to a road accident. They had gone on the motorcycle to fetch dinner for the family from a dhaba and were run over by a speeding truck near Shastri Nagar around 9.30pm.

ICICI Bank Q4 net profit falls 5 per cent to Rs 969 crore

MUMBAI: ICICI Bank reported a 5 per cent drop in its January-March quarter net profit to Rs 969 crore over the corresponding quarter the previous year, on higher expenditure and a drop in other income which got a boost last year from the sale of stake in a subsidiary. Net profit for the fiscal year 2018-19 fell by 50 per cent on year to Rs 3,363.30 crore on lower other income and increase in provisions.

TCS overtakes RIL to become most valued company again

Software services major Tata Consultancy Services on Thursday reclaimed the status of the country's most valued firm by market valuation, surpassing Reliance Industries Ltd (RIL). RIL shares have been on a downhill, falling for the fourth day in a row on Thursday. In four days, the shares have plunged 10.79 per cent to ₹ 1,255.15 on the BSE. Following the plunge in its share price, RIL's market valuation dropped to ₹ 7,95,628.55 crore on the BSE. "Reliance Industries is leading the massive fall in Nifty.

May hand over stuck projects to govt bodies for completion, top court warns Amrapali

The Supreme Court (SC) indicated on Wednesday it could take away the Amrapali Group's ownership of unfinished projects and hand them to government agencies, reiterating that it will protect the interests of tens of thousands of homebuyers after the realty developer failed to deliver flats despite being paid. Approximately 46,000 flats have not been delivered by Amrapali Group companies, which have the largest tract of land for a real estate developer across Noida and Greater Noida in the National Capital Region.

India joins US, Japan, and Philippines for naval drills in South China Sea

NEW DELHI: Two Indian naval ships joined their counterparts from the US, Japan, and The Philippines for a "Group Sail" exercise through the contested waters of the South China Sea, underlining India's commitment to working with partners to ensure safe and open sea lanes, the Indian Navy said in a statement on Thursday. Incidentally, the two ships –INS Kolkata and Shakti -- that participated in the "Group Sail" were the same vessels that took part in the International Fleet Review in China's port city of Qingdao as part of the 70th anniversary.

Want to ban burqa then outlaw 'ghunghat' too, says Javed Akhtar

Veteran lyricist Javed Akhtar on Thursday said he was not averse to enacting a law banning the burqa if it was accompanied with a similar action against the 'ghunghat' system prevalent among women in Rajasthan. Akhtar's comment came in the wake of the Shiv Sena mouthpiece on Wednesday urging the Modi government to emulate Sri Lanka in banning the burqa on grounds of national security.

McDonald's buys out partner, will temporarily shut 165 outlets

NEW DELHI: McDonald's has decided to temporarily shut down 165 of its outlets in north and east India after finally ending its six-year-long bitter battle with its Indian franchise partner, Vikram Bakshi, to take over the 50:50 joint venture, Connaught Plaza Restaurants (CPRL). While the terms of the deal, including the settlement of the contentious \$330 million claim by CPRL, were not disclosed by the two estranged partners, Bakshi, who exited the nearly 25-year-old JV, is padding up for a second innings in the domestic fast-food market.

Lok Sabha election 2019: UP, Rajasthan record around 50% polling till 3 pm

Voting began on Monday for the fifth phase of Lok Sabha election in 51 constituencies spread across seven states with many political bigwigs, including Rajnath Singh, Sonia Gandhi, Rahul Gandhi and Smriti Irani, being in the fray. About 8.75 crore people will decide the fate of 674 candidates in the fifth of the seven-phase elections. The Election Commission has set up 94,000 polling stations/booths and made elaborate security arrangements.

In a statement, Hamdard said: "Full capacity production and a well-planned distribution infrastructure are ensuring it is reaching all corners of the country."

IPL Final 2019: Ahead of final against CSK, Rohit Sharma identifies key player for Mumbai Indians

The lure of an unprecedented fourth IPL title or facing a Chennai Super Kings side they have beaten thrice this season isn't making Mumbai Indians skipper Rohit Sharma breathe easy. "We are not going into the final thinking about our fourth title. That will take care of itself. What they have done won't be a major concern. I would rather focus on my team. The tournament itself is the biggest challenge. I see every team as a threat.

Piramal, CPPIB in tie-up for India's 1st renewables InvIT

Mumbai: Piramal Enterprises Ltd on Tuesday said it has signed an agreement with Canada's largest pension fund manager, Canada Pension Plan Investment Board (CPPIB), to co-sponsor India's first renewable energy-focused infrastructure investment trust (InvIT). The proposed InvIT will have an initial targeted corpus of up to \$600 million with an option to scale up further, Piramal said in a regulatory filing.

The two countries have set up a joint working group that would identify subjects of cooperation in the energy sector, including ways to rein in global oil prices. The group, set up a month ago, will be co-chaired by a joint secret.

India's G.S. Lakshmi first woman to be inducted into ICC match referee panel

India's G.S. Lakshmi has become the first woman to be appointed to ICC's international panel of match referees and will be eligible to officiate in international games with immediate effect. Claire Polosak had become the first ever woman umpire to stand in a men's ODI, earlier this month. Lakshmi, 51, who first officiated as a match referee in domestic women's cricket in 2008-09, has overseen three women's ODI matches and three women's T20I matches.

Pat on the back from BAT to make Sanjiv Puri's job easier

KOLKATA: British American Tobacco plc, the largest shareholder in ITCNSE -0.82 %, has expressed confidence that the cigarettes-to-hospitality conglomerate will continue its excellent performance under new chairman Sanjiv Puri, in a virtual endorsement of his elevation. Addressing an election campaign at Aravakurichi in Tamil Nadu on Sunday night, the actor-politician said he was one of those "proud Indians" who desired an India with equality and where the "three colours" in the Tricolour, an obvious reference to different faiths, "remained intact."

Shrinking Moon generating lunar quakes: study

The Moon is shrinking as its interior cools — getting over 50 metres skinnier through the last several hundred million years — and causing quakes on the lunar surface, a study has found. Just as a grape wrinkles as it shrinks down to a raisin, the Moon gets wrinkles as it shrinks, researchers said. Unlike the flexible skin on a grape, the Moon's surface crust is brittle, so it breaks as the Moon shrinks, forming "thrust faults" where one section of crust is pushed up over a neighbouring part.

West Bengal poll campaign cut short by a day

NEW DELHI: The Election Commission (EC), in a first-of-its-kind decision, curtailed all electioneering in West Bengal by a day on grounds that the state government had failed to provide a level playing field to all candidates. In a six-page order, the commission took the unanimous view that some "special measures are urgently needed to arrest the prevailing situation in these nine parliamentary constituencies" to create a conducive law and order situation to hold free, fair and peaceful.

Vidyasagar bust vandalism: Trinamool submits 'proof' of BJP's 'involvement' to ECI

Intensifying its attack on the BJP over the desecration of a bust of social reformer Ishwar Chandra Vidyasagar in a college during BJP president Amit Shah's mega rally in Kolkata on Tuesday, the Trinamool Congress on May 15 released videos to claim that "BJP goons" damaged the statue. A Trinamool team comprising Derek O'Brien, Sukhendu Sekhar Ray, Manish Gupta and Nadimul Haque also met the Election Commission.

SoftBank, Tiger Global deliver \$220 million in fresh funds to Grofers

BENGALURU: Grofers has raised \$220 million from SoftBank Vision Fund and other investors, marking the biggest fundraising in India's online grocery delivery industry and ratcheting up pressure on larger rival BigBasket. The latest funding comes after the startup executed a quick turnaround plan following a fund-raising at a beaten-down valuation in February 2018. South Korean investment firm KTB Ventures and existing investors Tiger Global and Sequoia Capital also invested in the latest round, Grofers said on Wednesday.

Maharashtra adds Rs 4,300 crore to fight against drought

MUMBAI: Faced with criticism, especially from NCP chief Sharad Pawar, for not doing enough to tackle the severe drought in the state, CM Devendra Fadnavis used the audio-bridge technology to connect with 24,000 elected representatives and 884 sarpanchs in a week, listen to their problems and stress that funds won't be a constraint. In all, 8,862 crore will be spent to tackle drought in 139 tehsils across 22 districts, said a senior bureaucrat.

The Sunil Mittal-led telco, they said, needs to refocus aggressively on subscriber growth and traction to effectively combat the Mukesh Ambani-led telco.

'Demerger of consumer arm to be positive for Tata Chem'

MUMBAI: The demerger of the consumer products segment is an incremental positive for Tata Chemicals (TCL) because it unlocks hidden value of Tata Salt in a tax-efficient manner and without creating any cross-holdings, analysts said. Post demerger, TCL's chemicals business is available at an attractive price with a medium term upside of nearly 15%, according analysts. TCL's Consumer Products segment will be demerged into Tata Global Beverages (TGBL), which will be renamed 'Tata Consumer Products'.

Chandrayaan-2 will carry 13 payloads: ISRO

India's second Moon mission that is planned for a July launch will have 13 payloads and one passive experiment from American space agency NASA, the Indian Space Research Organisation (ISRO) said on Wednesday. The spacecraft with a mass of 3.8 tonnes has three modules — Orbiter, Lander (Vikram) and Rover (Pragyan). All the modules are getting ready for Chandrayaan-2 launch during the window of July 9-16 window, with an expected Moon landing on September 6, the space agency had earlier said.

The breakthrough came nearly five months after InSight, the first spacecraft designed specifically to study the deep interior of a distant world, touched down on the surface of Mars to begin its two-year seismological mission on the red planet.

Norway nets 'trained Russian weapon': A whale

A harness recovered from an unusually friendly white whale in north Norway may indicate the animal had been trained by the Russian navy as part of a marine mammal special force, experts in Norway have said. The harness, which had the words "Equipment of St. Petersburg" labelled on it, could be used to attach cameras or other instruments, the experts added. The beluga whale was first sighted last week in waters off Finnmark — Norway's most northerly county which borders Russia.

Joshna Chinappa, the second seed, successfully defended her title, beating the top seed Annie Au of Hong Kong 11-5, 8-11, 11-6, 11-6 in the summit clash. Ghosal, the top seed and finalist last year, ensured there was no slip this time when he downed the fourth seed Leo Au Chun Ming, also of Hong Kong.

Jacinda Ardern Got Engaged. New Zealand Almost Didn't Notice

WELLINGTON, New Zealand — Prime Minister Jacinda Ardern is engaged to be married, and it took a sharp eye for New Zealand to find out. Ms. Ardern, 38, and her partner of more than five years, Clarke Gayford, 41, became engaged over Easter weekend, a spokesman for Ms. Ardern confirmed on Friday. The prime minister made global headlines last June when she became the second elected world leader in modern times to give birth while in office, and she has since received widespread praise for her response to the Christchurch terrorist attacks.

Caster Semenya: Olympic 800m champion loses appeal against IAAF testosterone rules

Caster Semenya has lost a landmark case against athletics' governing body meaning it will be allowed to restrict testosterone levels in female runners. The Court of Arbitration for Sport (Cas) rejected the South African's challenge against the IAAF's new rules. But Cas said it had "serious concerns as to the future practical application" of the regulations. Olympic 800m champion Semenya, 28, said in response to the ruling that the IAAF "have always targeted me specifically".

Founded in 2013 by Ritesh Agarwal when he was 19, Oyo has achieved rapid expansion through a technology-driven franchise model, focusing mainly on small budget hotels. The company already claims to be the world's sixth-biggest hotel brand by room numbers and aims to become the largest by 2023.

Masood Azhar terror listing: U.N. Sanctions Committee meets amid positive hints from China

A decision on whether Pakistan-based Jaish-e-Mohammed chief Masood Azhar will be listed as a global terrorist by the United Nations will be known on May 1 as the world body's Sanctions Committee holds a crucial meeting, amid indications that China could lift its hold on the proposal to blacklist Azhar. The Council's 1267 Al Qaeda Sanctions Committee is expected to meet at the United Nations and the issue of Azhar's listing is likely to be considered.

Emperor Akihito: Japanese monarch declares historic abdication

In his last public address as emperor, Akihito handed over the symbols of power and thanked the public for their support during his 30-year reign. The 85-year-old was given permission to abdicate after saying he felt unable to fulfil his role because of his age and declining health. He is the first Japanese monarch to stand down in more than 200 years. Akihito technically remained emperor until midnight (15:00 GMT on Tuesday

Ferrer finished his 20-year career with 27 singles titles, fifthbest among active players behind the top four of Roger Federer, Rafael Nadal, Novak Djokovic and Andy Murray.

Trump's taxes show losses of \$1.17 billion over a decade

US President Donald Trump defended his real estate tax strategy, saying his business was "entitled" to write-offs following a New York Times investigation that showed he reported losses of \$1.17 billion between 1985 and 1994. "You always wanted to show losses for tax purposes," Trump tweeted on Wednesday. "Almost all real estate developers did - and often re-negotiate with banks, it was sport."

TCS set to become world's third-largest IT services company

NEW DELHI: Tata Consultancy Services Ltd (TCS) is set to surpass DXC Technology Co. to become the world's third-largest software services provider in fiscal 2018-19, marking the first change in the pecking order of the information technology (IT) outsourcing industry in two years. If TCS does surpass DXC, it will only lag behind International Business Machines Corp. and Accenture Plc. DXC Technology, formed by the merger of Computer Sciences with a division of Hewlett Packard in 2017.

Pakistani Christian woman once on death row for blasphemy leaves for Canada

ISLAMABAD, Pakistan — Nearly a decade after a Pakistani Christian woman named Asia Bibi was accused of blasphemy during a dispute over a bucket of water, then condemned to death and imprisoned for eight years, she has been finally allowed to leave Pakistan and join her family in Canada, her attorney and Pakistani officials said Wednesday. Bibi, a 51-year-old farmworker and mother of five, was acquitted of the capital crime six months ago by Pakistan's Supreme Court, which overturned her original conviction for blasphemy.

Croatian World Cupper Igor Stimac set to be appointed Indian football team coach

Former Croatia international and manager Igor Stimac will be appointed as the Indian men's team coach after the All India Football Federation's (AIFF) technical committee recommended him for the post. The committee, headed by Shyam Thapa, interviewed the four candidates for the post — Stimac, Albert Roca, Hakan Ericson and Lee — on Thursday and zeroed in on Stimac.

Cortizo Declared Winner in Panama President Race

PANAMA CITY (AP) — Panama's Electoral Court has declared opposition candidate Laurentino Cortizo the winner of the country's presidential elections. The court said Cortizo of the Democratic Revolutionary Party won 33%, with 95% of votes counted from Sunday's vote. It said Cortizo, a cattle rancher, will formally be named president-elect on Thursday. Cortizo said just after midnight Monday that "I call on all Panamanians to join in a national effort to correct the country's path, rescue the country and get the economy on the right track."

Nirav Modi denied bail for a third time, to remain in 'unliveable' UK jail

LONDON: Fugitive diamond merchant Nirav Modi was denied bail by a UK court on Wednesday for the third time in his extradition case to India to face charges in the Punjab National Bank fraud & money laundering case amounting to up to USD 2 billion and will continue to be lodged in a London jail described by his lawyers as "unliveable". His bail, which had already been rejected twice before by Westminster Magistrates' Court in London.

Facebook co-founder calls for tech giant's break-up, says Zuckerberg has become too powerful

NEW YORK: One of the co-founders of Facebook called on Thursday for the social media behemoth to be broken up, warning that the company's head, Mark Zuckerberg, had become far too powerful. "It's time to break up Facebook," said Chris Hughes, who along with Zuckerberg founded the online network in their dorm room while both were students at Harvard University in 2004. In an editorial published in The New York Times, Hughes said Zuckerberg's "focus on growth led him to sacrifice.

Trump says tariffs on \$200 billion of Chinese goods will increase to 25%, blames slow progress in trade talks

President Donald Trump said Sunday that tariffs on \$200 billion of Chinese goods will increase to 25% on Friday, despite repeated claims by the administration in recent weeks that trade talks with Beijing were going well. The tariff rate on those goods was originally set at 10%. Trump had initially threatened to increase the tariffs at the start of the year, but postponed that decision after China and the U.S. agreed to sit down for trade talks.

On the deepest dive ever made by a human inside a submarine, a Texas investor found something he could have found in the gutter of nearly any street in the world: litter. Victor Vescovo, a retired naval officer, made the unsettling discovery as he descended nearly 35,853ft (10,927 meters) to a point in the Pacific Ocean's Mariana Trench that is the deepest place on Earth, his expedition said in a statement on Monday.

Pakistan's rupee keeps sliding after IMF loan accord reached

KARACHI: The Pakistani rupee continued to fall to record lows on Friday, after the government agreed in principle to a \$6 billion loan from the International Monetary Fund that's expected to set tough conditions on Prime Minister Imran Khan's administration. The rupee, which lost 3.6 per cent on Thursday to close at 146.2 against the U.S. dollar in the interbank market, dropped further on Friday, dealers said, selling at 149.50 in the interbank market and 150 in the open market.

Nepali sherpa scales Mt. Everest for 23rd time; creates world record

A 49-year-old veteran Nepali sherpa has scaled Mount Everest for the 23rd time, breaking his own record in reaching atop the world's highest peak, media reports said Wednesday. Kami Rita Sherpa, who summited Everest 22nd time last year to set record of most summits on Mt. Everest, stood on top of the 8,850-metres peak together with other Sherpas on Wednesday morning, the Himalayan Times reported.

In "The Dead Don't Die," the latest from Jim Jarmusch and this year's opening selection, catastrophe takes the form of zombies, who rise from their graves to destroy the living.
