Oil firms raise aviation turbine fuel (ATF), or jet fuel and commercial LPG prices

New Delhi: Prices of flight tickets may rise further as oil marketing companies (OMCs) have raised the prices of aviation turbine fuel by around 5% across the four metro cities. In the national capital, jet fuel now costs ₹1,18,199.17 per kilolitre (kl), up 5.14% from ₹1,12,419.33 last month. Similarly, the price of jet fuel in Kolkata increased 4.65% to ₹1,26,697.08 per kl. In Mumbai and Chennai, jet fuel is now priced at ₹1,10,592.31 and ₹1,22,423.92 per kl, respectively, according to data from the OMCs.

Gross GST revenue growth slowed to 10.2% in September

Growth in India's gross Goods and Services Tax (GST) revenues slowed to a 27-month low of 10.2% in September, from around 10.8% in the previous two months. However, collections improved 2.3% over August revenues to touch ₹1,62,712 crore. Revenues from domestic transactions, including services imports, were 14% higher than the tax collected from these sources during September 2022. This is the fourth time that the gross GST kitty has crossed the ₹1.60 lakh crore mark in 2023-24, the Finance Ministry said.

Bihar government released the report of a caste survey conducted in the State; OBCs, EBCs comprise more than 63% of State's population

AT A TIME when the BJP and Congress are vying with each other for the OBC vote in the coming elections, Bihar Chief Minister and JD(U) supremo Nitish Kumar on Monday stole a march over them. Choosing Gandhi Jayanti to make the announcement, the Nitish government revealed the results of its caste survey, putting the combined OBC strength in the state at 63% - a 10% leap over their share estimated by the 1931 census, the last time caste enumeration was done in the country – and adding fresh vigour to the Opposition's demand for a caste census.

Concept of SC/ST, OBC reservation would not apply to minority institutions, says Madras HC

The Madras High Court has held that the concept of communal reservation or reservation for Scheduled Castes, Scheduled Tribes and other Backward Classes of citizens would not apply to minority institutions. The first bench comprising Chief Justice S V Gangapurwala and Justice P D Audikesavalu gave the ruling while partly allowing an appeal and a petition from Justice Basheer Ahmed Syed College for Women (Autonomous) in the city, assailing a November 2021 order, rejecting the extension of religion.

The Ministry of Railways Tuesday released its new All India Railway Time Table known as "Trains at a glance (TAG)" effective from 1st October, 2023. The new time table has included 64 services of Vande Bharat Trains and 70 other train services. "The new timetable is designed to enhance connectivity between various cities and reduce travel time. Passengers are advised to check the departure and arrival timings as per the new timetable," the railway ministry said while issuing the new All India Railway Timetable.

The World Bank retained India's growth forecast at 6.3% for the year 2023-24

The Indian economy is estimated to grow at 6.3 per cent in the current financial year 2023-24, showing resilience despite elevated inflation and global headwinds, the World Bank said in its India Development Update released Tuesday. Though the growth estimate by the Bank has been retained from its earlier update in April, it is 20 basis points lower than the 6.5 per cent growth estimate both by the government and the Reserve Bank of India (RBI) for FY24.

Sachin Tendulkar was announced as the Global Ambassador for the Men's Cricket World Cup 2023 by the International Cricket Council

With just two days remaining and for the ball to start rolling for the marquee tournament, theInternational Cricket Council (ICC) on Tuesday announced that it has chosen former Indiancricketer and 2011 world cup fame, Sachin Tendulkar to be the "ICC Global Ambassador forMen'sCricketCricketWorldCup2023."



The Hindustan Aeronautics Limited hands over twin seater variant of LCA Tejas fighter aircraft to Indian Air Force

The Hindustan Aeronautics Limited (HAL) Wednesday handed over the first trainer version of the twin seater Light Combat Aircraft (LCA) Tejas to the Indian Air Force (IAF) in Bengaluru. Seven more LCA twin seater aircraft will be delivered next year, the HAL said.

The company, which has over 57,000 employees across different functions, has collaborated with organisations such as ARAI, Bosch, Mathworks, SAE, and Tata Technologies, among others to provide its employees.

UGC to train over 1,000 teachers to teach Indian knowledge systems from degree level

More than 1,000 university teachers across the country are being equipped with a working understanding of Indian traditions, culture and way of life, to enable them to teach relevant courses on Indian knowledge systems at the undergraduate and postgraduate levels from the next academic session.

India's economic growth forecast for the current fiscal year has been raised to 6.3 per cent from 6.1 per cent earlier, the International Monetary Fund (IMF) said in its October 2023 World Economic Outlook (WEO) report that was released on Tuesday, October 10. The global lender expects retail inflation in the country to rise to 5.5 per cent in fiscal 2023-24 before easing to 4.6 per cent in 2024-25.

Cabinet approves MoU between India and France on cooperation in the field of Digital Technologies

The Union Cabinet on Wednesday approved the country's three separate memorandum of understandings with Papua New Guinea, France, Trinidad and Tobago in the field of digital technologies. The MoU (memorandum of understanding) with France intends to promote closer cooperation and exchange of information pertaining to digital technologies, and will mutually support each participant's goal to promote access to digital technology in their countries, according to an official statement.

India launches 'Operation Ajay' to evacuate Indian national from Israel-Hamas conflict zone

As the Israel-Hamas war escalated and countries scrambled to bring home their people trapped in the fighting or looking for a way out of the war zone, India Wednesday announced it was launching Operation Ajay to repatriate its citizens from Israel and Palestine starting Thursday.



Cabinet approves royalty rates for mining of Lithium, Niobium, and Rare Earth Elements strategic minerals

The Union Cabinet on Wednesday fixed the royalty rates for lithium, niobium and rare earth elements (REEs). Under the new regime, while the mines will be auctioned by the Centre, the royalty will continue to be accrued to the states where these minerals lie. Prior to this decision, there was no royalty rate specified for these minerals and it was pegged at 12% of the average sale price (ASP), similar to other unspecified ones.

Non-residents and foreign companies opening bank accounts in IFSC Gift City will not have to furnish PAN

Non-residents and foreign companies opening bank accounts in IFSC Gift City will not have to furnish PAN and instead file a declaration. The non-resident or the foreign company opening a bank account at the International Financial Services Centres (IFSC) will have to file a declaration in Form 60 and should not have any tax liabilities in India. The Finance Ministry has amended Income Tax Rules exempting non-residents opening a bank account from the requirement of submitting PAN.

'INDIA' alliance writes to Meta, Google to remain 'neutral' ahead of Lok Sabha election next year

New Delhi: The opposition INDIA bloc has written to Meta CEO Mark Zuckerberg and Google CEO Sundar Pichai over their social media platforms' alleged role in "aiding communal hatred" in the country and demanded that the platforms maintain neutrality in the upcoming elections. The letters came after the Washington Post newspaper flagged alleged bias of Facebook, WhatsApp and YouTube towards the ruling BJP and the Narendra Modi dispensation.

RBI starts pilot programme for wholesale digital rupee in call money market

The Reserve Bank of India (RBI) on Tuesday initiated a pilot program for the wholesale segment of its central bank digital currency (CBDC) in the interbank call money market, according to dealers from participating banks. Dealers said nine banks, including four public sector banks and five private sector banks, are participating in the e-rupee call money pilot. This is the second use case of testing wholesale CBDC.

RBI slaps Rs 5.39 crore penalty on Paytm Payments Bank for violating series of norms

The Reserve Bank of India (RBI) on Thursday imposed a monetary penalty of Rs 5.39 crore on Paytm Payments Bank for violating Know Your Customer norms, among others. RBI said Paytm Payments Bank had failed to meet certain regulatory provisions under Know Your Customer (KYC), as well as the norms on enhancement of maximum balance at the end of the day as indicated in the licensing conditions of payments banks.

EESL will set up an e-commerce portal that will feature electric appliances with the highest efficiency ratings

To encourage the adoption of energy efficient appliances, Energy Efficiency Services Limited (EESL), a joint venture of public sector undertakings (PSU) under the Ministry of Power, will set up an e-commerce portal that will exclusively feature electric appliances with the highest efficiency ratings. The objective of this exercise would be to "create demand" and encourage consumers to opt for electric cookers, fans, refrigerators and other devices that were rated "five star and above", Vishal Kapoor, CEO, EESL said at a conference on Friday.

Indian Oil Corporation to invest Rs 1,660 cr in joint venture with NPTC

Indian Oil Corporation, the nation's biggest oil firm, will invest Rs 1,660.15 crore as equity in a newly set up joint venture with energy major NTPC Ltd for setting up renewable power plants. In June, IOC and NTPC had formed a 50:50 joint venture company, IndianOil NTPC Green Energy Pvt Ltd, to set up renewable energy projects to meet round-the-clock power requirements of refineries of the oil company. In a stock exchanging filing, IOC said its Board in a meeting on October 13.

Skill India partners with Coca-Cola India to launch Retailer Skill Development Program

The National Skill Development Corporation (NSDC), operating under the Ministry of Skill Development and Entrepreneurship (MSDE), has unveiled a collaborative initiative with Coca-Cola India. This partnership aims to bolster the retail sector in Odisha and Uttar Pradesh through the 'Super Power Retailer Programme', as part of the Skill India Mission. The initial phase of the programme is being tested in Odisha, according to an official release.

Walmart invests USD 39 million in farmer livelihood enhancement in India

Walmart Foundation said that, since 2018, through its market access programme it has invested over \$39 million in India to reach 500 Farmer Producer Organizations/Farmer Producer Groups targeting 8,00,000 farmers, of which more than half are women. NGOs like PRADAN, ACCESS, Mercy Corps and Srijan are working with the Walmart Foundation's Market Access Program to provide on-ground impact.

It will also establish a research centre for the semiconductor R&D ecosystem, and develop local quantum services and infrastructure in India.

Google to assemble Pixel line of phones in India from 2024

Alphabet Inc's Google on Friday announced it will manufacture its flagship Pixel line-up of phones in India, the latest tech giant after Apple and Samsung to make devices in the country. Google said it will make the Pixel 8 in India and the devices will roll out in 2024. The tech titan outlined its plans at the annual Google for India event . Google senior vice-president for devices and services Rick Osterloh said the company will partner international contract manufacturers to make the phones. "We will start manufacturing Google Pixel series smartphones in India," Osterloh said at the event here.

India's contribution to global economic growth will rise by 2 percentage points to 18% in 5 years: IMF official

The International Monetary Fund expects India to increase its contribution to global growth over the next five years as the economy continues to grow fairly rapidly. India will likely account for 18 per cent of world growth by 2028, up from 16per cent currently, Krishna Srinivasan, director of the Asia and Pacific Department of IMF, told reporters in Mumbai on Thursday. India's faster growth compared with China's economic slowdown could see the South Asian nation make a bigger contribution to global growth than its larger rival — only temporarily — the latest IMF figures show.

Prime Minister Narendra Modi flagged off the country's first Regional Rapid Transit System (RRTS) Namo Bharat

Prime Minister Narendra Modi flagged off the country's first Regional Rapid Transit System (RRTS) on Friday, calling the Namo Bharat train a glimpse of India's promising future. Mr. Modi purchased a ticket and took a ride with schoolchildren on the completed 17-km stretch from Sahibabad to Duhai Depot in Uttar Pradesh; the full 82-km Delhi-Ghaziabad-Meerut corridor is scheduled to be functional by 2025.

RBI opens dated securities to help Russia park its rupee surplus

FSSAI has recommended the use of quick response (QR) codes on food products to help the visually disabled

The Food Safety and Standards Authority of India (FSSAI) has recommended the inclusion of QR code on food products for accessibility by visually impaired individuals stating that this will ensure access to safe food for all including individuals with special needs such as visually impaired individuals. In its recent advisory signed by Director, Science and Standards Division, Amit Sharma, the authority notes that ensuring inclusive access to information is a fundamental right of citizens.

iPhone maker, Taiwan's Wistron approved the sale of its India unit, Wistron InfoComm to the Tata Group.

Tata Electronics Pvt Ltd (TEPL), the Tata Group's manufacturing arm, is acquiring Wistron's operations in India for \$125 million (Rs 1,000 crore). That will make it the first Indian company to manufacture Apple iPhones. Taipei-based Wistron Corp's board on Friday granted approval "to sign the share purchase agreement with TEPL for the sale of its 100% indirect stake in Wistron InfoComm Manufacturing (India) Pvt. Ltd (WMMI). The transaction price is tentatively estimated as \$125 million (approximately NTD3.89 billion)," it said in a statement.

Indonesia is set to launch China-funded high-speed rail, first in Southeast Asia

Indonesia has launched Southeast Asia's first-ever bullet train, a high-speed rail line that will connect two of its largest cities. The \$7.3 billion project, part of China's Belt and Road infrastructure initiative and largely funded by Chinese state-owned firms, opened to the public on Monday following a series of delays and setbacks.



Pakistan's inflation rises to 31.4% year-on-year amid high energy prices

Pakistan's inflation rate rose to 31.4% year-on-year in September from 27.4% in August, statistics bureau data showed on Monday, as the nation reels from high fuel and energy prices. The country is embarking on a tricky path to economic recovery under a caretaker government after a \$3 billion loan programme approved by the International Monetary Fund in July averted a sovereign debt default, but with conditions that complicated efforts to rein in inflation.
