

#### Air Marshal Ashutosh Dixit Takes Over As AOC-In-C, Central Air Command

Lucknow: Air Marshal Ashutosh Dixit, Ati Vishisht Seva Medal, Vayu Sena Medal, Vishisht Seva Medal, assumed the appointment of Air Officer Commanding-in-Chief of Central Air Command on Sunday. Air Marshal Dixit was commissioned into the fighter stream of IAF on December 6, 1986. #### GST Collections Increase by 10% to ₹1.75 Lakh Crore in August

Goods and Services Tax (GST) collections in August went up by 10 per cent from the same period last year to Rs 1,74,962 crore, according to official statement of government. This growth was observed across all categories: Central GST (CGST), State GST (SGST), Integrated GST (IGST), and cess. A year before, the gross GST revenue collected in the month of August, 2023 was Rs 1,59,069 crore.

# Rubina Francis Wins Bronze in Women's 10m Air Pistol SH1

The 25-year-old para shooter Rubina Francis secured India's fifth 2024 Paralympics medal as she won the bronze medal in the women's 10m air pistol SH1 event with a final score of 211.1 in the final round. Rubina finished seventh in the qualification round, the same as she did three years ago in Tokyo.

But in our work, we are targeting over 100 Indian languages, because we find that there are 60 Indian languages which have over a billion speakers and over 125 languages that have over a lakh speakers each," said Manish Gupta, director at Google DeepMind, Google India. India Aims to Boost Alcoholic Beverage Exports to Rs 8,000 Cr

The commerce ministry's arm APEDA (Agricultural & Processed Food Products Export Development Authority) said that India currently ranks 40th in the world for alcoholic beverage exports. As per estimates, the country has huge unrealised export potential.

Israel's Tower Semiconductor and Adani's \$10 Billion Chip Project in India

In a major decision ahead of the state elections, Maharashtra cabinet sub-committee on industries, chaired by Chief Minister Eknath Shinde on Thursday approved four major projects totalling an investment of Rs 1.17 lakh crore that includes a semiconductor manufacturing project to be jointly set up by Israel's Tower Semiconductor and the Adani Group. The project to be set up in Panvel of Raigad district will entail a total investment of Rs 84,947 crore in two phases and is expected to create 15,000 jobs.

The State Bank of India (SBI) has announced the third edition of its flagship Asha Scholarship programme guaranteeing support to 10,000 meritorious students from underprivileged backgrounds nationwide. Interested students have time till October 1 to apply for this SBI scholarship, for which the application form, eligibility details and more are available at the official website — sbifashascholarship.org. Students from Class 6 to postgraduate level can now access scholarship ranging from Rs 15,000 to 20 lakh in a year. The programme offers specialised categories for school students, undergraduates, postgraduates, as well as those enrolled in IITs and IIMs in India.

### India Emerges as World's Second-Largest 5G Smartphone Market

According to a new report from Counterpoint Research, India has emerged as the world's second-largest market for 5G smartphones, trailing only behind China. 5G smartphones are becoming increasingly prominent across various price ranges in India. Prachir Singh, a senior analyst at Counterpoint Research, highlighted that significant contributions from brands like Samsung, Vivo, and Xiaomi, especially in the budget segment, have been key to this growth. "India became the second-biggest 5G handset market during the first half, overtaking the US.

As per the official statement from RBI on Friday, it has imposed a monetary penalty of Rs 5 lakh on Godrej Housing Finance Limited, Rs 5 lakh on Aadhar Housing Finance Limited, and Rs 3.5 lakh on Housing and Urban Development Corporation Limited.

# QCI Approves NTH Ghaziabad for Drone Certification

The Quality Council of India (QCI) has provisionally approved India's first drone Certification body to National Test House (NTH) Ghaziabad, country's premier industrial testing agency. The NTH will now certify drones or Unmanned Aircraft Systems (UAS) at a highly competitive price to promote drone manufacturing ecosystem in India.



#### IMF Upgrades India's FY24-25 GDP Forecast to 7%

The World Bank has raised its growth forecast for India's economy to 7 per cent for the current financial year (FY25), up from an earlier projection of 6.6 per cent, according to a statement released on Tuesday. This revision comes amid expectations of stronger economic performance, driven by key factors such as private consumption and investment. The report highlights that while the economy remains resilient.

TCL is engaged primarily in the business of lending, leasing, factoring, financing and distributing financial products. "CCI approves the proposed merger of Tata Motors Finance Ltd with and into Tata Capital Ltd," the regulator said in a post on X.

# Union Cabinet Approves Health Cover for All Aged 70 and Above

The government's move to provide health coverage to all persons aged 70 years and above will bring much-needed relief to millions of families and is a significant milestone in providing essential healthcare services to the elderly, industry players said on Thursday. The Union Cabinet had on Wednesday approved health coverage to all persons aged 70 years and above under the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PM-JAY) irrespective of their income, benefiting around six crore senior citizens.

"Acquiring entities must ensure that the classification of their merchants within MCC-9311 strictly adheres to the tax payments only....Merchants shall ensure UPI as a payment mode is enabled for the increased limit for the tax payments category," said NPCI in a circular.

# LIC Appoints Infosys for NextGen Digital Platform

State-owned Life Insurance Corporation (LIC) announced on Monday that it had signed up tech giant Infosys to develop a next-generation digital platform that will act as the foundation for new high-value business applications, such as customer and sales super apps, portals, and digital branches. The financial terms of the deal remain undisclosed. The tie-up with Infosys is part of LIC's "long-drawn" strategy, said a senior executive of India's biggest insurer.

#### India Becomes 6th Largest Market in MSCI ACWI

India has become the sixth largest market in the MSCI All Country World Investable Market Index (ACWI IMI), surpassing China and narrowly behind France. For the first time, India is the largest emerging market (EM) in the gauge that tracks the performance of global capital markets. Click here to connect with us on WhatsApp At the end of August, India's weight in the MSCI ACWI IMI stood at 2.35 per cent, 11 basis points (bps) more than China which is at 2.24 per cent. France has just 3 bps more weight than India.

India is set to become the world's third-largest economy by 2030–31, as per S&P Global India. The country is forecast to grow at an annual rate of 6.7 per cent. # Moody's Upgrades India's Economic Growth Forecast to 7.1% for CY 2024

New Delhi: Moody's has revised its calendar year (CY) 2024 growth forecast for India to 7.1%, from its earlier estimates of 6.8% in June, as it expects growth in the Asia-Pacific region to outpace the global economy. It, however, kept its India growth forecast for CY 2025 unchanged at 6.5%. The revision in India's growth forecast by Moody's comes a month after Moody's Ratings similarly upgraded GDP growth forecast to 7.2% in 2024 and 6.6% in 2025.

Dassault Aviation Expands Footprint in India with New Military MRO Subsidiary

India has taken notable steps in its journey towards becoming a maintenance, repair, and overhaul (MRO) centre for military aircraft and doubling the larger industry to \$4 billion by 2030 in recent months, with global aerospace majors like France's Dassault Aviation and the United States' (US') Lockheed Martin and Boeing either announcing or indicating substantial plans for India. At present, India is home to \$2 billion in MRO business.

#### NSE, BSE Revise Transaction Fees; New Charges Effective from October 1



China's weight in the index has halved since its peak in early 2021, according to a note by Morgan Stanley on September 17.
